



To facilitate the exercise, members authorised the following payments:

- Kshs 1,240,400.00 to be paid as allowances to individual beneficiary accounts
- Kshs 140,000.00 (One hundred and fourty thousand) to be paid to Jawamu Tours , Diamond Trust Bank, Kilifi branch, account number 0243301005
- Kshs 119,600.00 (One hundred and nineteen thousand, six hundred) be paid to the Fund Account Manager as temporary imprest to cater for fuel, water and other administrative costs.

Members further authorised payment of Kshs 47,000.00 (Fourty seven thousand) to pay for committee members' sitting allowance for the day's meeting (27/03/19)

Min4/18/01/04/2019 Moving the Constituency from Cooperative Bank to Equity bank kilifi

Members raised issues on the challenges of Cooperative Bank that delay operations of the committee and subsequently cause delays in project implementation. Some of the challenges raised by members include:

- Unnecessary and un-explained bank charges
- Unnecessary delays in payments that unfortunately lead to delay in implementation of programs and projects.
- Delays in issuance of bank statements and cheque books

A case in point was when the bank informed members to cancel a PMC training programme which was held on 21/03/19 because of payment delays.

After deliberations, members unanimously agreed to shift the account from Cooperative bank kilifi to Equity bank Kilifi.
