There were savings from the revision of cost totaling to Ksh. 2,200,000 which members agreed to distribute to the following new projects:

- ii) Mabirikani chief's office toilets- Ksh. 500,000
- iii) Dabaso chief's office toilets- Ksh. 500,000

MIN NO: NG-CDFC/KILIFI NORTH /05/30TH JUNE 2020: TABLING OF A CIRCULARS FROM THE BOARD.

The Fund Account Manager tabled circulars from the NGCDF Board ref:NG-CDFB/BOARD Circulars/ Vol.II(021) and (022) both dated 18th June, 2020 on administration of Education Bursary ,mock examinations and continuous assessment tests which emphasized the need to work on achieving the objectives of the scheme as:

 Contribution to the attainment of universal primary and secondary education as per Article 43 (1) (f) of the Constitution of Kenya through:

i) Support to the government in the attainment of 100% transition from primary to secondary level of education

ii) Contribution to an enhanced access to tertiary and university education with a view to match skills to market demand as intended in Kenya Vision 2030

iii) Enhancement of the retention rate for students in secondary schools, tertiary institutions and Universities.

iv) Contribution to improved performance in national examination through funding of mock examination and continuous assessment tests.

Members understood and agreed to prepare well in advance in mapping of needy cases and coming up of the Sub-committee.

2. Achieving universal healthcare for the old and vulnerable through payment of NHIF to the vulnerable group.

MIN NO: NG-CDFC/ KILIFI NORTH /06/30TH JUNE 2020: REALLOCATION OF FUNDS

It was observed that there were some difficulties implementing the tree planting project for financial year 2019/2020 at the chiefs' offices. There had been several proposals from Teachers asking for help in water harvesting as the schools have got challenges of having piped water.

The committee deliberated on the issue and authorized reallocation by change of activity of the environment project to schools for installation of water tanks for rain water harvesting instead of planting of trees at chiefs offices where survival of the trees was going to be very difficult and the plots of land on which the offices lied were very small to accommodate the number of trees.
