#### NG-CDFC KS/MIN 04/18/03/2020 BRIEFS ON THE AUDIT-OAG

The FAM indicated to the members that Officers from the office of the Auditor General were in the constituency for 12 days including field visits as was highlighted in the last meeting. The auditors went round to validate on the projects and ascertain the existence of the same.

The auditors gave a positive report concerning the implementation of projects and procurement process except in rare cases where some issues were raised.

The committee promised to improve in future on the areas raised to facilitate prudent utilization of funds allocated.

The FAM reported that he has already responded to the management letter and addressed the issues raised.

The FAM gave an explanation on the contract renewal process and said he had forwarded members details and credentials to NG-CDFB awaiting approval and gazettement.

### NG-CDFC KS/MIN/06/18/03/2020 FUNDS RECEIVED

The FAM informed members that the constituency has received ksh 14,000,000(fourteen Million) FY 2019/20 from the NG-CDF Board. He also indicated that ksh 21,000,000 FY 2019/20 has been disbursed and shall be received within the week. Additionally ksh
