

MIN2/17/NG-CDFC-MOLO/2021 – 2020-2021 PROJECTS.

The chair informed the committee that the 2020-2021 projects proposals for Molo constituency were approved except for one project, that is, the electricity project at Chiponde lane. On the same note, the chair also informed the committee that some funds were released by the board on the same.

The committee deliberated on the issue and agreed to prioritize projects for implementation as per the funds received.

The fund manager was advised to transfer the funds to their respective project management accounts for immediate implementation of the projects by the project management committees. The fund manager obliged to fasten the process.

MIN3/17/NG-CDFC-MOLO/2021 – RE-ALLOCATIONS

The chair informed the members that kapsita secondary school project of construction of a 20 students' capacity single laboratory to completion, for the financial year 2019/2020 - still need to be re-allocated as per the committee's deliberation on Minute - MIN3/13/NG-CDFC-MOLO/2020 - on 13th Aug 2020.

She continued to inform the committee that the above request was declined by the board on grounds of lack of management sustainability of the radio station program, on a letter dated Nov. 20th 2020.

The committee deliberated on the matter and agreed to re-allocate the same fund to Kapsorok primary school for the construction of 2 number classrooms to completion each at ksh 1,000,000.

The committee agreed on the matter and requested the fund account manager to fast track the process re-allocation.

The committee also deliberated on the request by the board-on the deferral letter dated 20th Nov. 2020- to specify whether the construction - of a partial perimeter wall (phase one) covering a distance of 144 meters- for Mary Mount Secondary school, would be done to completion. The committee confirmed that the amount of 1,150,000 for the project, would successfully complete phase 1 of the project which is 144 meters.
