MIN 08 KIM NG-CDFC 02/03/2021 PUNDA PRIMARY SCHOOL

The Chairman briefed members about the school challenges and what the community was facing. He said the school was registered as Punda Primary school but the NGCDF committee had forwarded the name Didmus Barasa D.E.B primary school to the NGCDF Board for the construction of 8 classrooms at total cost of Kshs 9,600, 000.00.and Kshs. 5,465,000.00 had been approved in the financial year 2020/2021.

Resolved That: Fund account manager communicate with the NGCDF board to change the name to Punda primary school since Didmus Baraza D.E.B primary does not exist.

Furthermore, the committee was informed that the contractor M/s Rom Son Holdings Ltd undertaking works at Punda primary school at a tender sum of Kshs. 5,120,000 for proposed construction of three number classrooms and sanitation block had abandoned the site with works on slab level for the three classrooms and sanitation blocks two in number three door each, but with poor workmanship and substandard works thus the community was not happy with the work that is ongoing, and requested to seek clarifications from PMCs and stake holders since the work done was substandard. They also requested the Clerk of works to attend the next site meeting.

Resolved That:

- 1. The clerk of works to appear in the next meeting to clarify and substantiate whether he was involved or not in the supervision of the project
 - 2. The members were urged adhere to the procedures for better project management.
 - 3. The NGCFC and the PMC and other stakeholders meet at the site and address the issues. A date for the meeting to be set later.
