The committee was informed that a contract to Unik Driving College for training students had issues and the fund had been pending in the books since 2019 .Students who had been allocated a total of Ksh. 250,000 had refused to undergo medical examination to establish their blood groups thus could not continue with the course thus the college could not be paid its LSO balance of Ksh. 250,000.

Members discussed and concluded to give the opportunity to other deserving students who were willing to undergo all the formalities of the course.

They approved another list of 25 students at Ksh 10,000 each for a total of Ksh. 250,000 to be paid to Unik Driving College.
