### MIN NO: NG-CDFC/KISAUNI/04/27<sup>TH</sup> AUGUST 2021: REALLOCATION

The Chairman informed the members that the land for construction of Barani primary School which had earlier been promised by the county government and later revoked by cost water works development agency because of the expansion of the water supply network.

It was later resolved to advertise for the expression of interest and as per the tender evaluation report the recommended bidder had quoted Kshs. 32,340,000 for 1.191 Ha (2.943 acres) of land title certificate number C.R.71781 whose market value is Kshs. 40,000,000.

The said piece of land had some encroachment of approximate 0.0185 Ha estimated to be Kshs. 435,500. Thus making it to be 1.1725 Ha at a cost of Kshs.31, 905,500.

Members deliberated on the matters above and resolved to reallocate the following projects.

Members deliberated and resolved to reallocate Kshs. 600,000.00 that was meant for **Kajiweni Primary School** to **Bamburi Primary school** and **Barani** to **Utange Primary School** to purchase approximate 118 three seater school desks @ Kshs. 6,000.00 as follows:

### Mwembelegeza Secondary School

The chairman informed the members that a borehole was drilled by a good samaritan but the school needs more toilets members deliberated to change from construction of 4 door flushable toilet, soak pit, septic tank, drilling of a borehole, construction of overhead tower and purchase of 5,000ltrs tank at an estimated cost of Kshs. 1,500,000, to construction of 6 door flushable toilets (2 for PWDs), urinals, soak pit, septic tank, piping the borehole water, purchase of 3,000ltrs tank at an estimated cost of Kshs. 2,000,000 but the school has unutilized Kshs. 1,070,000, additional of Kshs. 930,000 is needed, we have managed to get 108,000 from Kajiweni Primary School and Kshs. 108,000 from Barani that was meant to purchase 6 teachers tables and chairs @ an estimated cost of Kshs. 18,000.00 for each School.

### Concordia Secondary

The chairman informed the members that there is high demand of classrooms at Concordia since some students are learning under the tents. Members deliberated and resolved to add one more classroom storey building at an estimated cost. Construction of one additional Classroom storey building, besides the administration block, rump, 4 door flushable toilets for the administration block including external drainage work for the toilets all in one building. Members deliberated and resolved to reallocate Kshs. 4,000,000 from emergency fund F/Y 2020/2021 to Concordia Secondary School.

### MIN NO: NG-CDFC/KISAUNI/05/27<sup>TH</sup> AUGUST 2021: RESUBMISSION OF NG-CDF OFFICE PROPOSAL FOR THE FINANCIAL YEAR 2019/2020

The chairman informed the members that the land to procure has a shortfall of Kshs. 8,000,000 members deliberated and resolved to resubmit funds meant for construction of NG-CDF Office Kshs. 8,000,000.00 be resubmitted to procure the land for Mjambere Secondary School and Barani Primary School.
