KANG~ CDFC MIN 04: 9/9/2022 EMERGENCY REALLOCATION

Given the close of the financial year 2021/2022, the committee deliberated and proposed the reallocation of the balance of emergency vote, Kshs 1,392,207 to the following projects:

- 1. Kwamwenze Primary School- Construction of a 2-door pit latrine with a door for PWDs- Kshs 400,000
- 2. Kyai Primary School- Construction of a 2-door pit latrine with a door for PWDs-Kshs 400,000
- 3. Ngumuti Assistant Chief's Office- Additional funds for completion of assistant chief's office started by the community- Kshs 300,000
- 4. Kangundo NGCDF Office- Murraming of the office entrance(excavation, hardcore hand packing & compacting, blinding, levelling)- Kshs 292,207

The FAM is to write to the Board to request the approval.

KANG~ CDFC MIN 05: 9/9/2022 CHANGE OF ACTIVITY

The FAM brought to the attention of the committee that the Sub-county works officer had suggested that the activities of two projects needed to be reviewed because the budget was not sufficient to cater for all the project activities suggested.

One was 2021/2022 Kyaaka Primary School- Renovation of 3 classrooms to completion; new roof truss, new roof covering, flooring (ceramic tiles), fixing of windows, doors, new verandah, internal and external plaster, internal and external painting and electrical wiring- Kshs 1,650,000. The three classes were observed to be in very dilapidated state and the budget was only sufficient to renovate two after preparing the bill of quantities. Hence the suggested activity is: Kyaaka Primary School- Renovation of 2 classrooms to completion; new roof truss, new roof covering, flooring (ceramic tiles), fixing of windows, doors, new verandah,ramp, internal and external plaster, internal and external painting and electrical wiring- Kshs 1,650,000

The other was 2020/2021 Kakuyuni Police Station- Construction of a septic tank(Kshs 1,400,000), 5 One-Bedroomed Staff Houses(Kshs 2,400,000), 2-Door Pit Latrine and 2-Door

Bathroom(Kshs 400,000) to completion- Kshs 4,300,000. The station's leadership had suggested that instead of having an outside pit latrine and bathroom all the houses be made ensuite. Further, after preparing the bill of quantities the works officer observed that with the recent increase in the cost of construction inputs the initial budget would not suffice to complete all the work. The new proposed activity is now: Construction of a septic tank(Kshs 700,000), 4 One-Bedroomed Staff Houses ensuite (Kshs 3,600,000) ~ Kshs 4,300,000

The committee deliberated and approved the changes of activity. The FAM is to write to the Board to seek further authority.
