WS/NG-CDFC -6/05/2023: ALLOCATING MORE FUND TO BURSARY SCHEME

The committee allocated kshs20,068,555 to secondary school bursary and Kshs33,000,000 to tertiary institutions which is to 33.4% of constituency allocation to the current financial year. Due to over years' persistent droughts, many residents who depend on livestock have lost their income, this has led to upward increase in number of bursary applicants from 3,500 from previous financial year to 6,400 in Page 4 of 5

this financial year. The amount allocated to the bursary scheme was not commensurate to number of applicants. The committee request approval of the board to allocate additional funds to bursary scheme through reallocation and resubmission of the above projects. The committee agreed to allocate additional 1.3% to bursary scheme to cater for the increase in number of applicants
