MIN. NG-CDFC/KISAUNI/03/14TH OCTOBER 2019: MONITORING AND EVALUATION

The Chairman informed the members that the projects are ongoing well but there was need for a monitoring to be done with the relevant departmental heads. The Fund Manager was thus requested to prepare a three days budget for the same and the exercise to start from 22nd to 24thOctober.

MIN. NG-CDFC/KISAUNI/04/14TH OCTOBER 2019: REALLOCATION FOR THE FY: 2018/2019

The Fund manager informed the members that due to lack of land the Assistant County Commissioner's Office cannot be done hence there is need to reallocate the funds.

Members deliberated on this reallocation and resolved to construct a new school at Mwembelegeza since there is need for primary and secondary school. The title deed is already out for the construction of the School and due to lack of land thus proposed to reallocate the funds for Assistant County commissioner office **Kshs. 5,000,000.00** to additional funds for construction of six classrooms storey building at Mwembelegeza Primary school (New sciol).

The members also approved the following reallocation:

- 1. To change activity of the school since we have unutilized funds that were meant to construct 2No. Classroom, **Kshs. 150,000.00** from Concordia Primary to purchase 30 new three seater school desks **a Kshs. 5,000.00** for the newly constructed two classrooms as per the request from the head teacher.
- 2. To change activity of the school since we have unutilized funds that were meant to construct 4No. classroom storey building, Kshs. 776,950 from Concordia Secondary to purchase 100 new lockers and chairs @ Kshs. 7,600.00 for the newly constructed four storey building classrooms as per the request from the head teacher.
- 3. To change activity of the school since we have unutilized funds that were meant to construct four classroom storey building classrooms, **Kshs. 454,800.00** from Kiembeni Estate Primary School to purchase **90** of new three seater school desks @ **Kshs. 5,000.00** for the newly constructed two classrooms as per the request from the head teacher.
- 4. Junda Chiefs office toilets have already been constructed by the County Government thus the members agreed to reallocate **Kshs.** 615,643.00 that was meant for construction of 4no. door pit latrine at Junda chiefs office to construction of an office for the education officer at the District treasury.
- 5. Concordia Secondary **Kshs. 594,200.00** that was meant for construction of open drains and walk ways but the funds were insufficient. Hence the members deliberated and agreed to reallocate **Kshs. 535,000.00** that was meant for purchasing, delivery and planting of 330 seedlings at Kisauni Baptist Primary School
