RE: CHANGE OF PROJECT IMPLEMENTATION AT SCHOOL.


We appreciate that the Ng- Cdf Wajir -West allocated Arbajahan Secondary ksh 1,000,000 (One Million Shillings) the financial year 2020/2021 for pipping project, since the school had no connected pipped water. The project was not implemented due to delay of funds during that financial year.

The board of management wrote to many other institutions for help of the same project including the World Bank which drilled a borehole at Arbajahan Primary and pipped water to the Secondary.

Now that the school has sufficient pipped water, the Board of management wish to request the Ng- Cdf Wajir West for change of the project to renovation of three classrooms in the school. This is due to the dilapidated condition of these classrooms because of congestion from high enrolment.
