The Fund account manager informed members that he had received a circular NG-CDFB-CEO/MOE/VOL 1 (046) Dated; 16<sup>th</sup> October, 2023 i.e. “A letter received by the board from the Principal Secretary State Department for Basic Education RefNo. MOE.HQS/3/7/27 (110) dated 3<sup>rd</sup> October 2023 communicating on the impending programme of the Ministry of Education on infrastructure development for junior secondary school. Which, the national treasury had allocated funds in the Financial Year 2023/2024 for the construction of classrooms and integrated learning resource centres within selected junior secondary schools to be managed by the Ministry of Education and NG-CDF as a conditional grant.

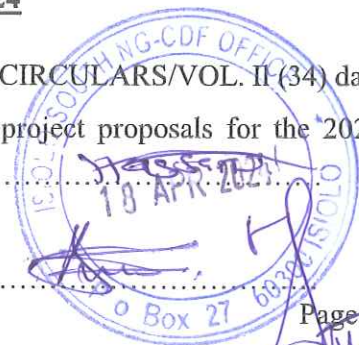

financial year. The implication of these amendments is to emphasize the new focus of the Fund towards matters that fall within the exclusive National Government mandates as per the Constitution of Kenya.

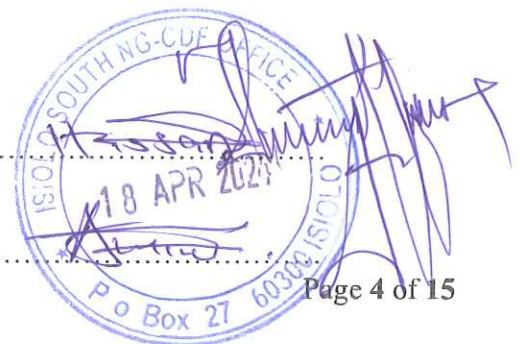
