# MIN. 1/04/09/2020: PRELIMINARIES

The meeting started at 10.00 am with a word of prayer led by Tabitha Mukethi. The Chairperson, Madam Lucy then welcomed and thanked the members for availing themselves for the meeting.

## MIN. 2/04/09/2020: PROJECTS PROPOSAL FOR FY 2020-2021

The FAM informed the members that the NG-CDF Board had released the allocation table for the financial year 2020-2021 and the allocation for the year is Kshs. 137,088,879.31 but there was an Appropriation in Aid (AIA) of **Kshs. 30,000** for sale of tender translating the allocation **Kshs. 137,118,879.31**.

The secretary CDFC tabled all the ward proposals for thorough deliberation by the committee.

Before deliberating, the Fund Account Manager gave the committee guidance on how those proposals should appear in terms of sectors as they are from the National Government Constituency development Fund Board.





She also presented percentages that should guide each budget especially for statutory allocations like administration, monitoring and evaluation, sports, environmental activities, emergency and bursary.

She informed members that the total allocation for this financial year is Kshs. 137,118,879.31 and the following are the statutory deductions;

The FAM advised the members on the need to share the balances fairly among the various administrative wards and also insisted on the need to prioritize the on-going projects.
