#### a. Issue of Projects Re-submission

#### a. Bursary Reports.

#### b. Funds Managers Reports

MIN 05/23/SEPTEMBER/2020/NG-CDF/NORTH IMENTI: PROJECTS MONITORING AND EVALUATION



The Secretary of the committee presented the Monitoring and evaluation report for discussion by members, it was noted that the last exercise was a success and the committee was impressed by the good work the project Management committee were doing in terms of projects implementation, it was reported that almost 90% of the projects under implementation were almost complete.

The committee noted that many projects were not labeled and, in such despite, good work the level of publicity was very low, the committee agreed that it should be made a requirement before any project starts a sign post should be erected and once the project is complete it should be well labeled and all these costs should be part of the total project cost.

## MIN 06/23/SEPTEMBER/2020/NG-CDF/NORTH IMENTI: PROJECTS PROPOSALS FOR THE YEAR 2020/2021

The Funds Account Manager informed the committee that the allocation table for the year 2020/2021 was ready and the Constituency was allocated a sum of Ksh137, 367,724.14

He also informed the Committee in preparation of projects proposals the committee should look in to the following requirements.

- i. Projects funded should have been identified in public forums and documented in the Ward Report
- ii. Where the project is eligible for funding i.e. projects that under national government functions and which must be community based benefiting a wider cross section of people and projects that foster sustainable development.
- iii. Priority to be given to on-going projects
- iv. Regional Balance
- v. Adherence to statutory ceilings
- vi. Branding of projects where the cost of labeling should be included in the total project
- vii. Projects submitted should be in line with constituency strategic Plans.

After lengthy discussions the committee proposed the following projects for approval by the CDF Board.
