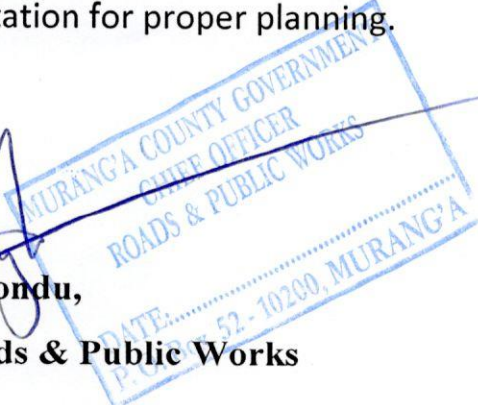


**RE: REQUEST FOR CONSTRUCTION OF OFFICES AT KAIRO
