0.0 INTRODUCTION OR BACKGROUND

0.1 ABOUT CDF

National Government Constituency Development Fund (NGCDF) is a Government of Kenya programme to devolve funds at constituency level. It was started in the year 2003 through an Act of parliament and the aim was to empower local community and give them power to choose the development project closer to their needs.

So far the NGCDF funds have been proven to be effective for the last sixteen (16) years and have impacted positively the livelihood of local residents at grassroot level.

0.2 About GITHUNGURI

Githunguri Constituency is in Kiambu county Githunguri subcounty and it is among the twelve (12) constituencies in Kiambu County. It is divided into five (5) wards namely:Githunguri,Komothai,Ikinu,Githiga and Ngewa wards

It's further subdivided into twenty one (21) sublocations. The Constituency has an area of 175.2km² and is centrally placed within the county.

The major key economic activities in the constituency is dairy farming due to available market for the milk which is facilitated by farmers dairy cooperative society namely Fresha Dairy. The constituents also engage themselves with cash crop farming (coffee & tea), and horticultural farming and its proximity to major towns like Nairobi and Thika provide market opportunities for the agricultural products. The constituency also prides itself in a rich resource base including very fertile arable land, rivers and dams.

The constituency has various primary and secondary facilities for easy access to education and also access to health and other social amenities is closer to the people.

PRELIMINARIES

The area chief called the meeting to order and requested one of the community member to open the forum with a word of prayer. He then welcomed all the guests and the local residents and thanked the NGCDFC committee for involving the community members towards prioritization of projects for funding through the NGCDF funds.

SPEECHES

FUND ACCOUNT MANAGER SPEECH

In her speech, the fund manager informed the gathering that the aim of NGCDF funds is to develop infrastructure, create wealth and eradicate poverty at constituency level. She further said that NGCDF is under national government and thus the projects that are eligible for funding are projects in education and security sector.

She further said that the project must be community based meaning that it will benefit a widespread section of residents in a particular area and on that not she stressed that NGCDF does not fund any religious institution or activities or community based organizations(CBO) like youth groups or Women groups. She thus requested the community members to present project proposals that will go hand in hand with the requirements of the NGCDF Act.

NGCDFC CHAIRMAN REMARKS

The NGCDFC chairman Mr.Kabari appreciated the Komothai residents for their attendance. he cited the projects that the NGCDFC Committee have undertaken in the ward for the past two years that include; renovations of classrooms at Thuita Pry,Nginduri Pry,Komothai Pry and Kibichoi Primary schools, Construction of toilet block at Komothai pry and Komothai special school ,renovation of multipurpose hall at Nginduri Pry.School, Construction of additional rooms at Gatiiguru,Gathugu and Kiberethi AP Posts.

He further informed the residents that NGCDF Funds are released in every financial year and thus the committee will continue funding projects in equitable manner across the constituency.

ACC REMARKS

In his remarks, the ACC said that security is of paramount importance for any development to take place and thus the community members must volunteer to give information to the security officers in order to improve security in the area. He also appreciated the work of the NGCDFC Committee for construction of AP posts at Komothai Ward which are now operational and he hoped with deployment of security officers the security will be beefed up.

The NGCDFC Chairman took the residents through the process of presenting their proposals. Members presented both oral and written proposals.

He also thanked the NGCDFC team for involving the local residents in identifying projects that will be beneficial to them. He also reminded the residents to embrace nyumba kumi initiative in order to fight any level of insecurity in the area.

SPEECHES

1. NGCDFC CHAIRMAN REMARKS

Mr. Joseph Kabari the NGCDFC Chairman expressed his gratitude to the area residents for honoring their invitation by attending the meeting. He then called upon the NGCDFC members for self-introduction. The NGCDFC Chairman highlighted the projects that the NGCDF committee have already carried out in the ward that include; Construction of classrooms at Gathirimu Girls, renovation of classrooms at Kambui Girls, Construction of toilet block at Nyaga primary and construction of multipurpose hall at Mitahato sec.school. He called for patience of other institutions since the NGCDF will continue funding projects every year.

2. FUND ACCOUNT MANAGER REMARKS

In brief, the Fund manager informed the participants that NGCDF funds is controlled and managed as per the NGCDF Act. The Act specifies the nature of projects to be undertaken and implemented at constituency level. She said that the project must be community based meaning that the benefit of the project will be enjoyed by a widespread people residing in that area. For that reason she clarified to the residents that NGCDF does not cater for personal issues like payment of hospital bills etc and does not support any religious organizations or activities. She further informed the residents that since the creation of devolved Governments (County Governments), NGCDF funds projects that are in education and security sectors since it is under National Government. She however said that NGCDF Githunguri is working closely with County Government and Kenya Rural Roads Authority in order to ensure that all sectors including roads and health sector are as well taken care of in order to achieve the desired development in the constituency.

3. ASSISTANT COUNTY COMMISSIONER REMARKS

In his remarks, the ACC Githunguri emphasized that security start with every individual and thus people must embrace and tolerate one another in order to have peace and harmony at grassroot level. He also

challenged the parents to counsel and guide the youth who are being otherwise misguided and recruited into illegal gangs that are causing a lot of insecurities in our villages.
