Ex-Min: 3/10/01/2018 PROJECT VISITS & PUBLIC BARAZAS

Public barazas: There was an additional baraza held at Ruku Police Post on 19th January 2018. This was necessitated by complains from the community members of Ruku area that the Public baraza for Muguga Ward held at Kamuguga Polytechnic was too far for them. Due to the size of the ward, the committee agreed to hold the extra baraza which increased the budget of the barazas by the following components

The PLWD fraternity was properly represented in every ward.

The Chiefs' offices in the constituency are okey but their staff houses are mostly dilapidated.

Projects visit:

There were needs in every area members visited. The committee noted that the former committee had done a commendable job. The new committee will have to surpass that work which had been done by the former committee.

The committee noted the need of ablution blocks for most schools cutting across the constituency.

The security offices were good but the police staff houses were in a deplorable state and others are not enough to accommodate the Officers.

The FAM reported that they had a discussion with the Hon. MNA and Chairman on the need to move the NG CDF main account from equity bank to Family bank. They received a proposal from Family bank who are in the process of opening a branch at Wangige. After looking at the proposal and getting into a discussion with a few staff from Family bank, they concluded that Family bank is offering better services than Equity bank due to the following reasons:

- Equity bank charges shs. 55 for clearance of all cheques. This especially during the bursary cheques issuance is a big amount. Family bank does not have these charges.
- Family bank promised to take up some projects in the constituency e.g. providing water tanks to schools as a corporate social responsibility. Equity bank does not have such projects
