Arising from MIN 25/END/NG- CDFC/10.09.2019 PUBLIC MEETINGS FOR 2019/2020 PROJECT PROPOSAL it was observed that the public participation forums held in the wards by the committee were well conducted and people turned up in large numbers. The meetings were graced by area member of parliament Hon. Dr. Robert Pukose himself and the NG-CDF team. The deliberations of these meetings will inform and guide the committee in preparing the constituency proposal for 2019/2020.

MIN 32/END/NG-CDFC/11.10.2019 Disbursement of Funds to projects

The committee discussed and approved disbursement of funds to the following:

Ksh 450,000 to Endebess Recreation and Social Development CBO Project Management to facilitate purchase of sports uniform, materials and sports items (balls, uniforms and boots)for the constituency football team (Endebess Football Club). The team is participating in national super League division II.

Ksh 821,000 to Endebess Sports Committee C.B.O Project Management Committee to organize procure sportsitems (balls, uniforms) for football, volleyball and athletics teams, and support the Endebess Marathon to be held on first week of December 2019.

Ksh 540,000 to Maendeleo Kwa Wote CBO as the Project Management Committee to implement lockers project.

Ksh 512,000 to Costacom Supplies Ltd for supply of computers and computer accessories and Ksh 350,000 for supply of office furniture.

Ksh 700,000 to Endebess Environment Team CBO Project Management Committee for supply of indigeneous tree seedlings.

Ksh 800,000 to Endebess Environment Team CBO Project Management Committee for supply of exotic tree seedlings to various institutions in the constituency.

MIN 33/END/NG-CDFC/11.10.2019 Project Reallocations/Change of Project Activity

The fund manger informed the committee of the status of the status of various requests for treallocations as had been requested by the committee.

Request for reallocation of funds (Ksh 1,500,000) from purchase of 3 acre land to construction of twin laboratory by Nalulingo Secondary school was approve. While request by the committee to reallocate funds for construction of 1 classroom to completion of 2 classrooms at Kitum Girls and reallocation of funds (Ksh 1,600,000) from construction of 2 classrooms to additional funds towards construction of dormitory at Japata Secondary School were conditionally approved by the board. However, request by the committee to reallocate funds (ksh 3,000,000) from drilling of a borehole at Endebess NG-CDF offices to additional funding of the Constituency Innovation Hub was declined. The committee discussed at the length the details of the reallocation status above and after lengthy discussions resolved the following.

1. To immediately disburse the reallocated funds for Nalulingo secondary school to enable immediate commencement of the project.
2. To clarify the areas pointed out by the board for all the conditionally approved projects
