**MIN 01/1/17/2024: PROCEEDINGS**

**MIN 03/1/17/2024: MATTERS ARISING**

There were no matters arising.

**MIN 04/1/17/2024: ONGOING PROJECTS**

The FAM informed the members that there were only 4 ongoing projects that required funding to completion with one project having incurred variation during implementation and the contractor was in touch with the school PMC to ascertain how much he was to be paid. The projects were therefore discussed and agreed by the committee to be funded and given first priority as tabulated below;

**Show Ground Assistant Chief's Office and Kahuho Primary School** was not considered for funding since the contractor had not submitted the variation BoQs and thus amount to be paid not known. The committee agreed that once the documents are availed and justified, the variation cost will be settled.

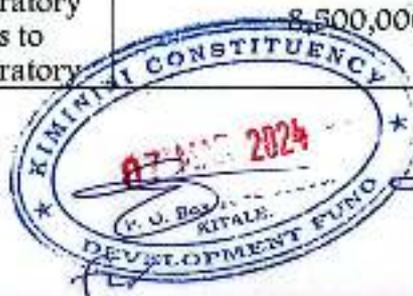
**Sikhendu Secondary School** was allocated Kshs.7,500,000 in 2020/2021 financial year for construction of a storey building of 6 classrooms. The funds for the project were delayed and disbursed in August, 2023. This led to delay in implementation of the project, change in cost estimates and more funds needed to ensure completion of the classrooms. The estimates drastically changed due to high cost of market prices of materials.

Michael Wamalwa Secondary School, Birunda was allocated funds in 2022/2023 for construction of a dining and AIC Kapkoi Sisal Secondary School for construction of a laboratory but were not captured in the 2023 ongoing report submitted to the Board since valuation of the pending works had not been done.

#### MIN 05/1/17/2024 NON-ALLOCATION OF FUNDS

The committee also discussed the following project that had been proposed but was not funded fully to completion due to inadequate funds and prioritization of the ongoing projects. The members had agreed to allocate enough funds in the financial year 2023/2024 financial year to ensure completion of the projects during submission of 2022/2023 financial year. All other projects were funded apart from St. Theresa Girls High School because the school principal had made a request to change of project activity from twin non storey to four number storey science laboratory which has been submitted to the NG-CDFC.

### MIN 06/1/17/2024 Infrastructure Development for Junior Secondary Schools

The Fund account manager informed the meeting the Board had issued a circular notifying the NGCDFC of Infrastructure Development for Junior Secondary schools dated 16<sup>th</sup> October, 2023 and Ministry of Education circular Re: Infrastructure Development for Junior Schools dated 3<sup>rd</sup> October, 2023.

NG- CDF Kiminini Constituency was allocated Kshs.18,200,583 as a conditional grant proposed to be jointly managed by the Ministry of Education and the NG- CDF to ensure synergy and timeliness in implementing the program.

In addition, the allocation was based on grade seven (7) enrolment and as a constituency, the committee is required to match a shilling to a shilling to enable realization of the objective of the program. The Sub County Director of Education Madam Isabella Ainda had listed JSS schools to be funded and thus the committee discussed and after deliberations, the NG-CDFC agreed to fund the following projects;
