OVERVIEW OF THE CONSTITUENCY

1.2.1 Position and size of the Constituency

Nandi Hills Constituency is one of the Six Constituencies in Nandi County, Nandi East Sub County. The Constituency was established in 2013 after being carved out of the larger Tinderet Constituency alongside two other Constituencies of Tinderet and Engwen. Nandi Hills Constituency has four elective wards namely Nandi Hills, Chepkunyuk, Ollessos and Kapchorua all represented by Members of the County Assembly (MCAs) as well as 23 Locations and 66 Sub Locations. The constituency is currently represented by Hon. Alfred Keter who was first elected in 2013.

The Sub County has its headquarters at Nandi Hills town and borders Tinderet to the south, Kesses to the east, Aldai Sub county to the west, Engwen to the north east and Chesumei to the north. The total area of the Sub County is approximately 432km² with a population of 107,724 inhabitants.

1.2.2 Administrative and political Units

Nandi Hills Sub County comprises of two divisions, twenty three locations and sixty five sub-locations, with Four Electoral Wards, namely Ollessos, Chepkunyuk, Nandi Hills and Kapchorua Wards.

1.2.3 Settlement Structure

The population density in the Constituency is very high ranging from 300 persons per Km² in Nandi Hills Location to 100 persons per Km² in Koilot Location. This is based on the 2009 Housing and Population Census. The High density in Nandi Hills Location is attributed to the proximity to the urban center – Nandi Hills Town.

Permanent settlement areas in the Constituency are found in all the 21 locations. In all these locations, there exist good agricultural soil for tea growing and very appropriate climate for dairy animals keeping particularly Ollessos ward has high milk producing potential. Market centers are available in Nandi Hills town and within the surrounding multinational tea estates with very conducive social infrastructure like schools and health facilities that support human settlement.

2.0. OVERVIEW OF PROJECTS FUNDABLE UNDER NG-CDF ACT

➤ The eligible projects fundable by NG-CDF as stipulated in section 24 of the NG-CDF (Amendment) Act, 2016 as those that are in:

1. Respect of works and services falling within the functions of the National Government as outlined in the Constitution.
2. Projects that are community based in order to ensure that the prospective benefits are availed to a widespread cross-section of the inhabitants of a particular area.

2.0.1 The ineligible projects include:

1. Projects supporting religious bodies or religious activities.
2. Projects supporting political bodies or political activities.
3. Project/activity that is recurrent in nature.
4. Projects involving personal awards whether in kind or cash.
5. Projects targeting a specific club or group of people to the exclusion of others.

6. Projects falling within the devolved functions as outlined in the fourth schedule of the constitution of Kenya.

1.1 ABOUT NG-CDF.

The Constituencies Development Fund (CDF) was established under the Constituencies Development Fund (CDF) Act, 2003, amended in 2007 and repealed by the CDF Act of 2013. In 2015, the CDF Act of 2013 was declared unconstitutional and a new Act was enacted in 2015, being the National Government Constituencies Development Fund Act (NG-CDF Act, 2015). The National Government Constituencies Development Fund (NG-CDF) is under the Ministry of Devolution and Planning.

The Constituency Development Fund (CDF) was introduced in Kenya in 2003 with the passage of the CDF Act 2003 by the 9th Parliament of Kenya which was repealed in 2013 by the CDF Act 2013. The CDF Act provides that the government dedicates a minimum of 2.5% of all National Governments' share of annual revenue towards community projects identified at constituency level by communities.

The fund was designed to bring about equitable development and reduce poverty at the constituency level by providing mechanisms for supplementing implementation of the National Government development Agenda at the constituency level.

The CDF program has facilitated the putting up of education facilities in all parts of the country, including remote areas that were usually overlooked during funds allocation in national budgets.

7. WARD MEETINGS REPORT

1.1 Background

The open public meetings held across the Constituency were organized in compliance with the provisions of the Constitution of Kenya 2010 on public participation and further pursuant to the provisions of the NGCDF Act 2013 (As amended in 2016). The Constitution specifically under Article 201(a) provides that *"there shall be openness and accountability, including public participation in financial matters."* Accordingly, Article 10(2)(a) on national values stipulates that *"the national values and principles of governance include the rule of law, democracy and participation of the people."*

The open forum public meetings were also convened and held pursuant to the provisions of Section 24(6) of the NGCDF Act 2013 which provides that *"the Chairperson of the Constituency Committee shall, within the first year of the commencement of a new Parliament and at least once every two years thereafter, convene open forum public meetings in every Ward in the Constituency to deliberate on development matters in the Ward and in the Constituency"*

The forums were important in engaging the public on NGCDF matters and getting vital feedback critical in Constituency projects identification, prioritization, implementation and overall management. It is also noteworthy that the data from the open forum meetings shall also greatly inform the development of the Constituency Strategic Plan 2021/2022-2025/2026.

1.2 Basis for Convening the Meetings

The Nandi Hills NGCDF open forum public meetings were convened and held pursuant to the provisions of the Constitution of Kenya 2010 and more specification pursuant to the stipulates of Sec 24(6) of the NGCDF Act 2013 which provides that *"the Chairperson of the Constituency Committee shall, within the first year of the commencement of a new Parliament and at least once every two years thereafter, convene open forum public meetings in every Ward in the Constituency to deliberate on development matters in the Ward and in the Constituency"*

These meetings were convened and held in identified venues in every Ward within the Constituency in order to ensure greater reach in projects deliberations and prioritizations due to the challenges of distance and terrain.

1.3 Importance of the NGCDF Public Participation Forums

Citizen participation in project planning, management and implementation planning requires the involvement of concerned stakeholders. This includes identifying public concerns and values and developing a broad consensus on planned initiatives. It is also about utilizing the vast amount of information and knowledge that stakeholders hold to find workable, efficient and sustainable solutions.

Public participation encompasses a range of procedures and methods designed to consult, involve, and inform the public to allow those that would be potentially affected by a decision or policy to have input into the process. Community participation motivates the stakeholders to work together, recognize the benefits of their involvement and own the projects in their localities.

Stakeholders play a central role in setting up priorities and objectives of development initiatives by ensuring relevance and appropriateness. It is important that all stakeholders are therefore involved in the development of NGCDF projects and not just direct beneficiaries of an initiatives.

While acknowledging the provisions of the NGCDF Act 2015 and the Constitution of Kenya on public participation, the NGCDF Committee were cognizant of the fact that the open forum public meetings would:-

- i) Give people of diverse backgrounds a chance to express their views on the Fund.
- ii) Help in understanding the community's needs and resources requirements.
- iii) Offer valuable insights into the community priorities and planning requirements.
- iv) Motivates the stakeholders towards teamwork, and project ownership.
- v) Provide a database for guiding and explaining actions of the NGCDF Committee.
- vi) Enhance linkages and cooperation between the NGCDF Committee and the community.
- vii) Provide vital feedback on projects to inform the preparation of the Constituency Strategic Plan 2021/2022-2025/2026.

3.4 Planning Requirements

To ensure success of the forums, the following requirements and plans were critical:-

- i) Securing the meeting places and venues.
- ii) Inviting the NGCDFC members.
- iii) Mobilizing the community members
- iv) Inviting the area leaders.
- v) Preparing a programme of the entire meetings.
- vi) Preparing a detailed report on previous projects priorities and bursary funding.
- vii) Coordination with the public participation facilitators.
- viii) Securing the NGCDF vehicle and other resources needed for success.
- ix) Preparation of all attendance registers and project prioritization forms.
- x) Finalization on transport and logistics including securing motor vehicles.
- xi) Periodic communications with NGCDFCs, Chiefs and Assistant Chiefs prior to the meeting day.

1.5 Guidelines Issued

In furtherance of the above, the Nandi Hills NGCDF Chairperson and the Fund Account Manager wrote to all area leaders, Deputy County Commissioner, Assistant County Commissioners, Chiefs, Assistant Chiefs, NGCDF members and all Project Management Committees on the guidelines and requirements for the effective public participation programme.

The communication were prepared and delivered on time as required to give them adequate time to read and prepare for the forums.

1.6 Attendance

It was noteworthy that the attendance during all the open forums across the Constituency was impressive and representational. It was noted that the meetings attendance took into account the geographical diversity, communal, social and cultural interests in the Ward and the requirements of gender, youth and representation of persons with disabilities;

Pursuant to this, the Nandi Hills National Constituency Development Fund Committee (NG-CDFC) invites members of the General Public, Community Leaders and all Stakeholders to participate in project identification and prioritization exercise in the Constituency.

3. Projects that do not support political and religious bodies and
4. Projects that are in respect of works and services falling within the devolved functions of the county government.

3.6 COMMENTS BY THE NG-CDTC CHAIRMAN

He highlighted on the achievements so far within the constituency explaining that it was a constitutional requirement that they all participate in identifying the projects to be funded in the constituency, and stressed the need of all the stakeholders to come together during planning to avoid duplication and double funding of projects. He called upon the County Government through the area member of county assembly who was present to share their development projects publicly to enable the constituents be aware of projects being implemented in their areas.

3.7 COMMENTS BY THE AREA MEMBER OF COUNTY ASSEMBLY

- The Area MCA reiterated upon the members present to continue sensitizing the public, on bursary application requirements and focus on those really needy cases so as to be able to be assisted by being given a full assistance to cover the entire course. He urged them to focus mainly on development issues and not politics. He insisted to the members that due limited funds all the projects cannot be implemented at once but gradually hence the need of setting priorities.
