1.0 Background on NGCDF

The National Government Constituencies Development Fund (NG-CDF) is established under Section 4 of the NG-CDF Act 2015 as amended in 2016, with an objective of addressing poverty and regional development imbalances by dedicating a minimum of 2.5% of the National Government share of annual revenue as divided by the annual Division of Revenue Act enacted pursuant to Article 218 of the Constitution. The funds are geared towards community driven development projects in every constituency identified and implemented at grassroots level.

The Fund is managed by the NG-CDF Board, which is a Body Corporate established pursuant to Sections 14, 15 and 16 of Act. At the constituency level, the day to day management of the Fund is vested on the National Government Constituency Development Fund Committees that are in place in each of the 290 constituencies countrywide.

The main mandate of NG-CDF Board is to consider project proposals submitted from various constituencies in accordance with the Act, approve for funding those projects proposals that are consistent with the Act and send funds to the respective constituency fund account of the approved projects.

- Limited resources – the needs are more than the funding
- Inadequate funding to the projects
- Prolong funding to the project
- Lack of monitoring to already funded projects
- Lack of involvement of relevant government departments

7.1.5 Way-forward

- Projects to be allocated enough funds
- Projects to be funded and be completed within three years as per act.
- Monitoring work plan and budget to be prepared and ensure its implementation.
- Involvement of works officer in preparation of engineer's estimates and supervision of projects.
- Involvement of chain and supplier's department in preparation of procurement documents.
