INTRODUCTION (BACKGROUND)

0.1. ABOUT NG-CDF

1. The National Government Constituencies Development Fund (NG-CDF) was established under the Constituencies Development Fund (CDF) Act 2003, amended in 2007 and repealed by the CDF Act of 2013. In 2017, the CDF Act of 2013 was declared unconstitutional and a new Act was enacted in 2017, being the National Government Constituencies Development Fund Act, (NG-CDF) act, 2017. The national government constituencies development fund (NG-CDF) is under the ministry of devolution and planning. The objective of the fund is to provide mechanisms for supplementing implementation of the national government development agenda at the NG-CDF level.

0.2 ABOUT BOMET EAST CONSTITUENCY

Bomet East constituency is in the south rift region. It is a one constituency/district/Sub-county. It is one of the five constituencies that form Bomet County. Bomet East Constituency headquarters is in Longisa shopping centre.
