NGCDFC /MIN. 001/05/2020: PRELIMINARIES

The meeting commenced at 11.30 a.m. with a word of prayer from Ms. Susy Lichuma Andayi. The chairman welcomed members to the meeting.

NGCDFC /MIN. 002/05/2020: READING AND CONFIRMATION OF THE PREVIOUS MINUTES

The minutes of the previous meeting were read by the secretary which were confirmed by Mr. Yunus Akhonya Salim and seconded by Mr. Gaxton B. Makheti as a true record of the previous meeting.

NGCDFC /MIN. 003/05/2020: RESUBMISSION OF PROJECT FOR 2019/2020 F/Y

The manager informed the members that the NGCDF Board declined to approve Kshs. 2,000,000.00 allocated for construction of Administration block at KMTC Navakholo on the ground that the amount was too little for commencement of the project. He further informed the members that Kshs. 5,000,000.00 allocated for Navakholo Dairy Cooperative was deferred since it falls under devolved activities. The members discussed and resolved that

Kshs. 7,000,000.00 be allocated to KMTC Navakholo for construction of administration block (Excavation, laying of foundation and slab) and resubmit to the NGCDF Board for reconsideration and approval.

The members further agreed that during the year 2020/2021 the committee will allocate Kshs. 20,000,000.00 for the project and the balance for completion of the project to be allocated in 2012/2022 financial year.
