## MIN MMSE/CDF/2/17/02/2021: PRELIMINARIES.

The chairperson welcomed the members to the meeting and asked for cooperation in the days Agenda. She then welcomed the MP to give his remarks.

#### MP'S REMARKS.

He expressed his pleasure to meet the committee members and asked them to remain focused on serving the interest of NGCDF Mumias East and be fair in their transactions. He reminded the members that the CDF funds are distributed equally across all the constituencies in the country and therefore necessary for the committee to ensure that the people of Mumias East benefit from the CDF funds.

He appreciated the committee's effort to compart the spread of Covid-19 within the constituency and asked them to maintain the same spirit since it has a positive impact on the Residence of Mumias East.

## MIN MMSE/CDF/3/17/02/2021: RESUBMISSION AND REALLOCATION.

The FAM informed the committee there was 4 projects with were conditionally approved for FY 2019/2020 proposed budget and the board needed more information as follows:

### 1. St. Martha Mwitoti Secondary School and Mukambi Primary School

The board requested NGCDFC to submit more information on when to complete the projects and if there is commitment within 3 years.

#### 2. Nyaporo and Lusheya ACC's offices

The board requested for justification on the cost of fencing. The clerk of work assigned to liaise with the public works for justification.

#### Way forward

Members discussed on the need to reallocate funds from other projects to facilitate the buying of more 13.78 acres land at an estimated cost of Kshs. 1,200,000.00 which is readily available for KMTC Shianda expansion which was key in realizing the desired goals as earmarked by the committee. The acquisition and fencing will cost committee Kshs.18, 500,000.00.

The Secretary Mr. Orao was asked to give a status report from the land sellers, which he did confirm to members that the land owners were very positive and that the negotiations are almost complete, except money factor was slowing the process.

The committee deliberated on the issue and approved that the FAM do a resubmission request to the board as follows:
