## **1.0 INTRODUCTION**

The NG-Constituency Development Act 2015 stipulates in part 5 section 27 subsection 1 and 2 that the chairperson of the NG-CDFC shall, within the first year of the commencement of a new Parliament and at least once every two years thereafter, convene open forum public meetings in every ward in the constituency to deliberate on development matters in the ward and in the constituency.

The NG-CDFC shall then deliberate on project proposals from all the wards in the constituency and any other projects which the Constituency Committee considers beneficial to the constituency, including joint projects with other constituencies, consider the national development plans and policies and the constituency strategic development plan, and identify a list of priority projects, both immediate and long term, out of which the list of projects to be submitted in accordance with the Act shall be drawn from.

Citizen participation in project planning, management and implementation planning requires the involvement of concerned stakeholders. This includes identifying public concerns and values and developing a broad consensus on planned initiatives. It is also about utilizing the vast amount of information and knowledge that stakeholders hold to find workable, efficient and sustainable solutions

Public participation includes a range of procedures and methods designed to consult, involve, and inform the public to allow those that would be potentially affected by a decision or policy to have input into the process. Community participation motivates the stakeholders to work together, recognize the benefits of their involvement and own the projects in their localities.

Stakeholders play a central role in setting up priorities and objectives of development Initiatives in order to ensure relevance and appropriateness. It is important that all stakeholders are involved in the development of projects, right from identification to implementation and sustainability. Ownership becomes easy unlike if not involved in all the stages of project cycle.

### **1.1 ABOUT NG-CDF**

The Constituency Development Fund (CDF) was introduced in Kenya in 2003 with the passage of the CDF Act 2003 by the 9th Parliament of Kenya which was repealed in 2013 by the CDF Act 2013. The CDF Act provides that the government set aside at least 2.5% of its ordinary revenue for disbursement under the CDF program.

The fund was designed to support constituency-level, grass-root development projects. It was aimed to achieve equitable distribution of development resources across regions and to control imbalances in regional development brought about by partisan politics. It targeted all constituency-level development projects, particularly those aiming to combat poverty at the grassroots and entrench equitable distribution of development.

The Constituencies Development Fund (CDF) was established under the Constituencies Development Fund (CDF) Act, 2003, amended in 2007 and repealed by the CDF Act of 2013. In

2015, the CDF Act of 2013 was declared unconstitutional and a new Act was enacted in 2015, being the National Government Constituencies Development Fund Act, NG-CDF Act, 2015.

The National Government Constituencies Development Fund (NG-CDF) is under the Ministry of National Treasury and Planning.

The objective of the Fund is to provide mechanisms for supplementing implementation of the National Government development Agenda at the constituency level.

The NG-CDF program has facilitated the putting up of new water systems, health, Security and education facilities in all parts of the country, including remote areas that were usually overlooked during funds allocation in national budgets.

## **1.2 ABOUT KHWISERO NG-CDF**

Khwisero Constituency is an electoral constituency within Kakamega County; the constituency's IEBC number is 208.

Khwisero Constituency was cut off from Butere Constituency, where it was a division. It borders the following constituencies: Ikolomani and Lurambi to the North, Butere on the North West, Gem to the West and Emuhaya to the East.

Khwisero constituency has four wards namely: - Kisa Central, Kisa west, Kisa North and Kisa East. It has two divisions – Khwisero East and Khwisero West.

#### **Eligible Projects Fundable by Khwisero NG-CDF**

The eligible projects fundable by NG-CDF as stipulated in section 24 of the NG-CDF (Amendment) Act, 2016 as those that are in:

- Respect of works and services falling within the functions of the National Government under the 2010 Constitution.
- Must be community based to ensure that the prospective benefits are available to a widespread cross-section of the inhabitants of a particular area.

#### **The ineligible projects include:**

- Projects supporting religious bodies or religious activities
- Projects supporting political bodies or political activities
- Recurrent costs of a completed projects
- Personal awards
- Projects targeting a specific club or group of people to the exclusion of others
- Projects addressing devolved functions as outlined in the fourth schedule of the constitution of Kenya

According to NG-CDF Act 2015, Section 27 Subsections 1, 2 and 3 require that the NG-CDF Committee chairman shall, within the first year of the commencement of a new parliament and at least once every two years thereafter, convene open public meetings in every ward in the constituency to deliberate on development matters in the ward and in the constituency. It is therefore imperative that fresh proposals are collected for our next budget.

The NG-CDF Committee must accord priority to completion of on-going projects before new ones are initiated. Kindly take note that we shall be

The following must be adhered to by the constituents:

- 1) All proposed projects must be community based in nature, not for a few individuals;
- 2) The projects must be under National Government, not devolved ones - Education (excluding Nursery schools), Security, Sports and Environment.
- 3) Purchase of land is allowed as a project, but the constituents must avoid land with ownership wrangles and cost price must be realistic as per market price in the area.
- 4) The ward list must be arranged in priority form since not all proposed projects can be funded in one financial year.

The proposals will be implemented in two financial years before fresh proposals are collected. The NG-CDF Committee will then meet to compile a final budget for the Constituency before submitting to the NG-CDF Board through the Fund Account Manager for funding.

### **3.2.2 PRELIMINARIES**

The area chief called the meeting to order and called upon one volunteer to lead in opening prayers.

### **3.2.3 COMMENTS BY THE AREA CHIEFS**

- He thanked the NG-CDF Committee chairman for initiating this public open forum towards project identification.
- The Area chief (for Mulwanda Location) requested the NG-CDF Committee to furnish the newly built ACC's offices. Although it is accommodating many officers, including chief, it lacks modern furniture.
- He promised to coordinate his colleagues and Assistant chiefs to avail their written proposals, which he would submit to NG-CDF offices.

### **3.2.4 COMMENTS BY THE DEPUTY COUNTY COMMISSIONER (AG.)**

- Commended the public for their attendance.
  - He thanked the chairman for convening such a public meeting in which the public share their comments on NG-CDF kitty.
  - He reminded the public to avoid *disco matanga* for school going youths to concentrate on their education.
- He encouraged the public to go for Hustler Fund so that they can do small businesses.
- Security will be improved to ensure constituents live peacefully.

### **3.2.5 COMMENTS BY THE NG-CDF CHAIRMAN**

- Commended the public for attendance.
- He urged the public to prioritize the projects they would like to be done for them.
- He also highlighted the projects that have so far been funded by NG-CDF, especially the storey buildings in our public secondary schools. New ones are also in the pipeline for implementation.
- He reminded the public that some projects are devolved hence they need County Government Intervention. NG-CDF cannot fund such devolved projects - roads, health and water.

### **3.2.6 COMMENTS BY THE FUND ACCOUNT MANAGER**

- It is important to stick to projects falling under National Government functions - Education, Security, Sports and Environment.
  - The proposals being collected from the public shall be used in two financial years while budgeting. Will be used for 2022/2023 and 2023/2024 financial years after which the NG-CDF Committee will go back to *wananchi*.
  - He urged the constituents to play an active oversight role so that value for our money can be realized.
- Those who get elected as PMC members should be transparent to the constituents since not all constituents can be members to the PMCs.

### 3.3 WARD II: KISA WEST WARD

The meeting took place on Wednesday the 28<sup>th</sup> December 2022, at Shirombe Chief's camp - Social hall at 2:00pm.

### **3.3.2 PRELIMINARIES**

The meeting was started off by the Area Chief, who invited a volunteer to give a word of prayer. There was a brief introduction led by the NG-CDF Committee chairman. The FAM explained to members why we had the public forum.

### **3.3.3 COMMENTS BY THE AREA CHIEF**

The meeting was attended by two chiefs from Shirombe Location Kisa West Ward. The chief for Kisa West location was not present as he had other commitments elsewhere. He was represented by one of his Assistant chiefs. The chief thanked the NG-CDF office for organizing the forum where they told the locals to be free to front their project proposals. Manyulia Police Post requested the NG-CDF Committee to assist in renovating their houses; put up pit latrine and bathroom as well as fence the compound.

### **3.3.4 COMMENTS BY THE DEPUTY COUNTY COMMISSIONER (AG.)**

The DCC complimented the members of the public for turning up. He stated that projects should not be imposed on the public be it education projects. He also commended the NG-CDF Committee chairman for putting project identification open to the public. Such reduces complaints from *wananchi*. He reminded the constituents to go for Hustler Fund to enable them start/run small businesses instead of staying idle.

### **3.3.5 COMMENTS BY THE FUND ACCOUNT MANAGER**

- The fund account manager stated that it was imperative that the members of the public and the administration had come out to support the forum urging them to be open in airing their suggestions.
- The FAM insisted that it was important to cite projects that will help the community and not projects that are political or those that support religious bodies or individuals or certain groups of people.
- He also made it known to the participants that the forum is carried out after every two years and as such it was significant for the participants to utilize the opportunity. The proposals being collected would be used in budgeting for two financial years -2022/2023 and 2023/2024.
- The NGCDF Committee will meet and prioritize projects during budgeting based on received proposals.

### **3.3.6 COMMENTS BY THE NG-CDFC CHAIRMAN**

The chairman informed the meeting that NG-CDF only dealt with projects that are funded by the National Government such as Primary schools, Secondary schools, Security, Sports and Environment. In addition, he commended that all projects that are ongoing should be owned by the community especially the bursary projects that touches on the youths. In addition, he stated that all the ongoing projects in the ward will be completed in time. The NG-CDF Act allows the committee to implement projects for not more than three financial years and the committee shall endeavor to do so.

#### **3.4.2 PRELIMINARIES/COMMENTS BY THE AREA CHIEF**

The meeting commenced with a word of prayer from a volunteer in the ward after being called to order by the Area Chief, Madam Hellen Watulo.

- The chief thanked NG-CDF Committee for funding construction of her offices. However, she noted that bats are a nuisance as they easily access the office. The open door should be modified to close completely.

- The office requires wiring and electricity connection, furnishing, floor tiles and ceiling to make it look neat.

- She informed the members present that she has no pit latrine and visitors normally go to the neighboring health facility, which is not pleasant.

#### **3.4.3 COMMENTS BY THE DEPUTY COUNTY COMMISSIONER (AG.)**

He stated that it was important for the participants to be part and parcel of the development process through engaging fully in project identification process so that after the project is completed they are in a position to own the projects. It is the right of every citizen to have a say in public resource allocation as per the 2010 Constitution.

He warned the constituents of not letting their children go to school. It is a mandatory requirement that any child of school going age should remain in school to improve on literacy level in the constituency.

Parents should take up their parental responsibilities and ensure that they pay school fees for their children. Bursary kitty cannot sustain all children in school, but those totally needy and bright. He reminded the public that they should go for Hustler Fund to enable them start/run small businesses instead of staying idle.

### 3.4.4 COMMENTS BY THE FUND ACCOUNT MANAGER

The Fund Account Manager stated that it was important for the members to understand that NG-CDF cannot fund devolved projects.

- He added that projects proposed should be those that will be beneficial to the entire community, but not those that meet personal or private needs of individuals.
- Proposals being submitted shall be used by the NG-CDF Committee for budgeting purposes for two financial years and the public should not politicize the budget process since all proposals cannot be funded in one financial year due to scarce resources. These proposals shall be utilized for 2022/2023 and 2023/2024 financial years.
- This financial year, due to the amended NGCDF Act 2022, Khwisero will receive fewer funds than some of our neighbors because the sharing formula depends on the number of wards. The higher the number of wards the higher the allocation.

### 3.4.6 COMMENTS BY THE NG-CDF CHAIRMAN

- He appreciated the participation of the members and the ability of the members to distinguish the devolved projects and National Government projects at the time of giving the project proposals.
- He added that it was significant for the members to come up with project proposals, but they should be aware that resources are minimum and as such, the project activities will be done in stages to completion provided funding does not exceed three financial years as per the NG-CDF Act 2015 (amended 2022).

**3.5.2 COMMENTS BY THE PRESENT AREA CHIEF**

- It is high time for the NG-CDF Committee to ensure all offices funded under security have electricity, ceiling board and well furnished. They do not expect separate funds to be released from National Government for funding such.
- They require at least a computer as the world is digital currently.
- Some Assistant Chiefs require modern offices, which should start with purchase of land. Generally, most of the Assistant chiefs and their Chiefs have new offices, funded by NG-CDF.

**3.5.3 COMMENTS BY THE DEPUTY COUNTY COMMISSIONER (AG.)**

- His role is coordinating with Area Member National Assembly for prioritizing project because resources are scarce.
- The public have the constitutional right to propose realizable projects, to address the needs of the entire public.
- Security projects should be emphasized - NG-CDFC should increase allocation towards Security sector as without security not much can be realized.
- Hustler Fund is available and accessible. The public should go for it so that they can start small businesses.

**3.5.4 COMMENTS BY THE FUND ACCOUNT MANAGER**

- It is an important exercise, which is done after every two financial years.
- Resources are scarce and therefore not all proposals can be funded in one financial year.
- We are collecting projects proposals as per the Constitution 2021 and NG-CDF Act 2015.
- Priority shall be given to all ongoing projects before new ones can be funded.
- Such proposals shall be used for two financial years - 2022/2023 and 2023/2024.
- Not all proposals can be funded in one financial year. The constituents should bear in mind since the NGCDF Committee will do a budget based on how the requests were prioritized.

**3.5.5 COMMENTS BY THE NG-CDF COMMITTEE CHAIRMAN**

- The exercise is constitutional and shall always be carried out after every two financial years. Currently, we have a 13<sup>th</sup> Parliament; hence the need to seek views from the constituents before budgeting is done.
- All projects proposed must reflect interests of the community and not a few individuals/groups.
- Better to have fewer proposed projects for funding than spreading very many of them, which would have no economic impact on constituents.

### 3.6 CHALLENGES

- ✓ Overdependence on NG-CDF funding for all projects - it is not easy to fund all proposed projects as the resources are scarce.
- ✓ Political interference in the budget process - those who do not have an allocation feel some are favored.
- ✓ Interests are all over. Hence, not all constituents can be satisfied.


### 3.7 RECOMMENDATIONS AND WAY FORWARD

- ✓ All modern Administration blocks should have ceiling board and electricity connection
- ✓ Furniture should be budgeted for in the offices since they have no furniture to match the buildings.
- ✓ All our floors have been a serious challenge. They tend to become dusty shortly after completion. It is recommended that any new building be done inclusive of terrazzo/tiles as a permanent solution.
- ✓ A number of schools have no enough land for construction. Therefore, storey buildings should be encouraged in both primary and secondary schools.
- ✓ Instead of depending entirely on bursary for children's education, parents should be advised to honor their parental responsibilities of paying fees for their children. Only very needy, but bright students be supported by NG-CDF.

- ✓ To have value for money, the constituents should be encouraged to play their oversight role by continuously monitoring their projects being implemented.
- ✓ Contractors who do shoddy work should be blacklisted, not to be awarded any more contracts.
- ✓ Branding/labeling of NG-CDF funded projects should be emphasized and the cost factored in the project estimated cost. This is important for accountability and transparency. Remember there are many sources of funding presently and the public should know who funded what.
- ✓ Those identified as Project Management Committee (PMC) members should be knowledgeable in management of projects for better quality results especially on record-keeping and returns.

### 3.8 CONCLUSION

We thank the people of Khwisero for turning up to participate in the ward forum meetings. This has enabled the NG-CDF Committee to work within set timelines as concerns budget proposals.

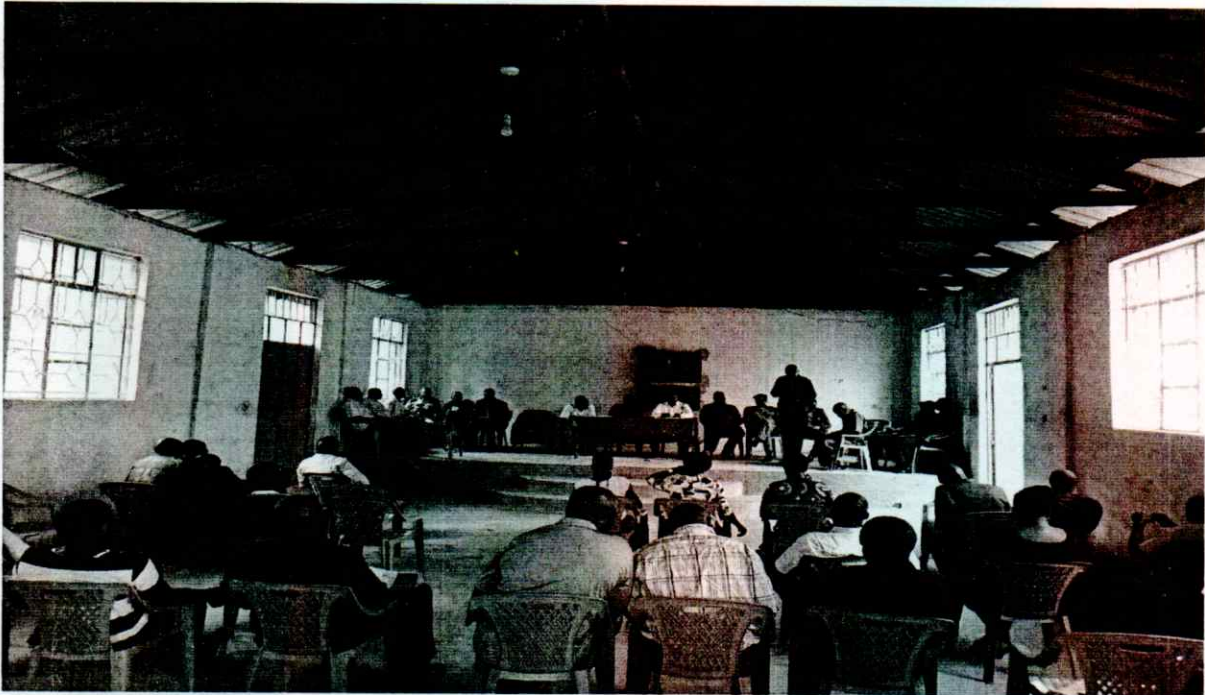

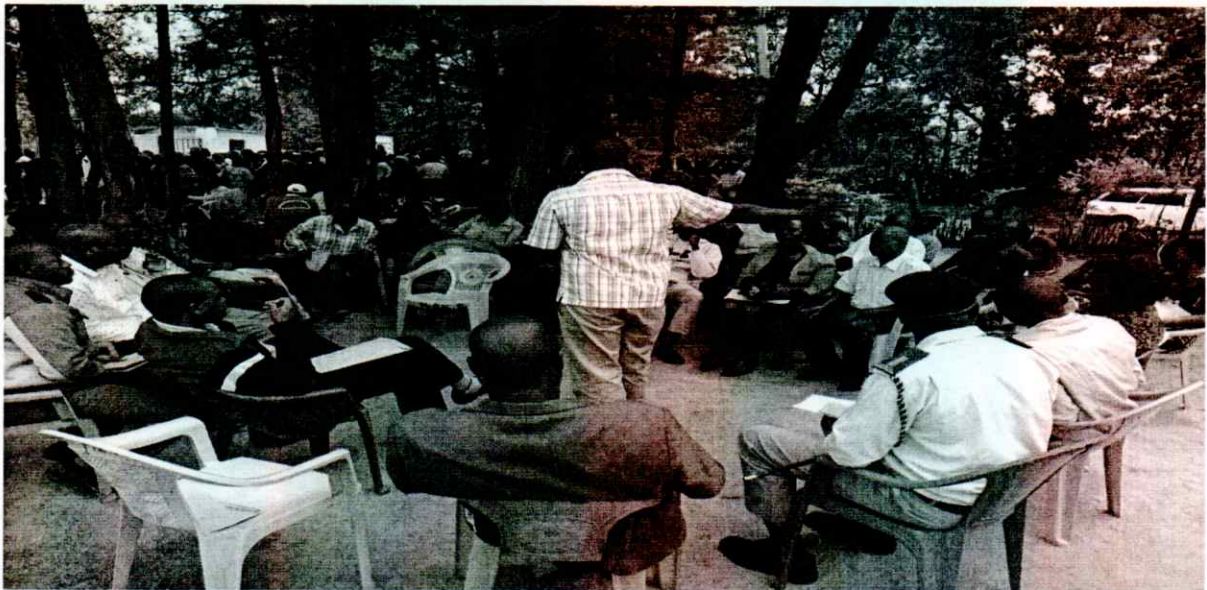

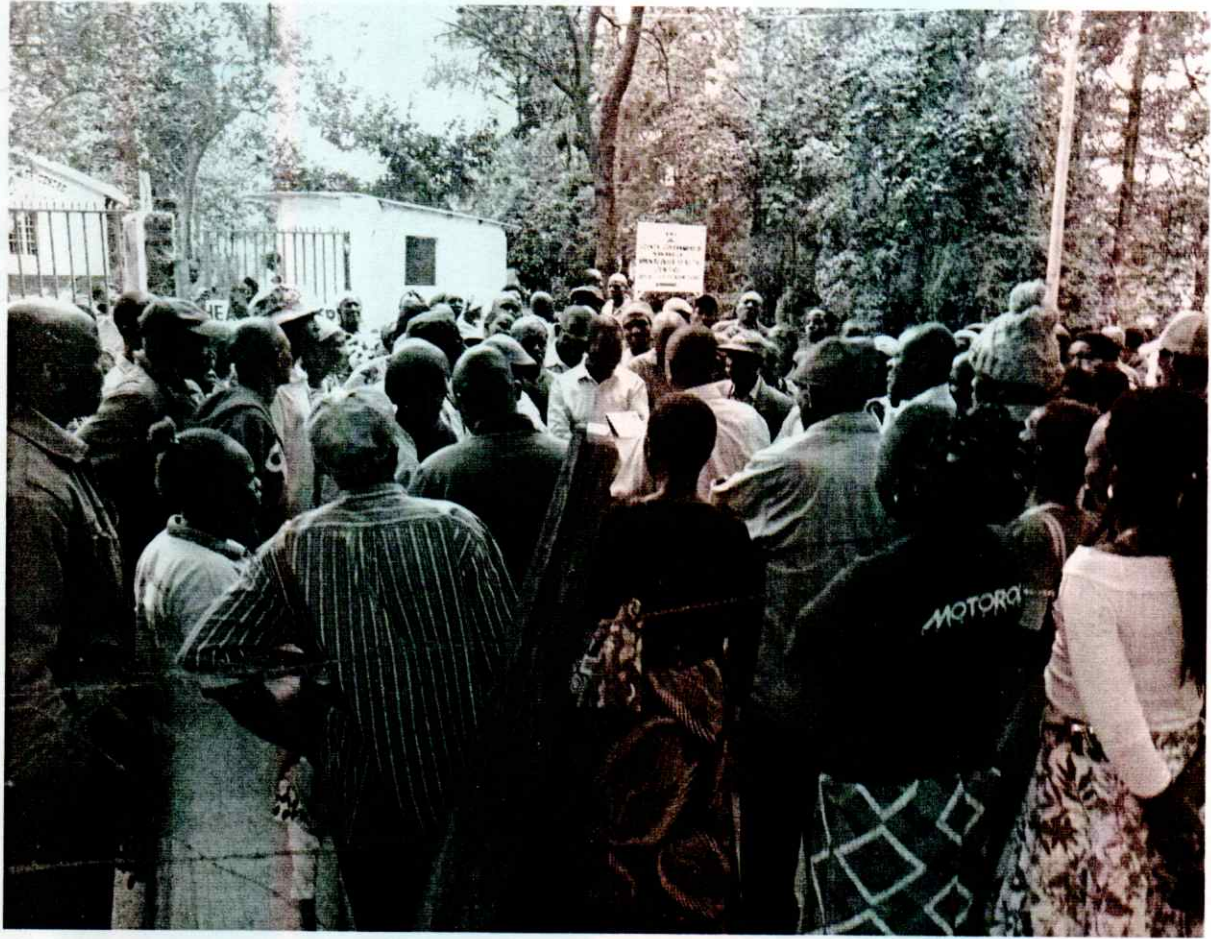
