MIN1: 08/09/2021 - PRELIMINARIES

The Chairman called the meeting to order at 10.30 a.m. A word of prayer was offered by Mr. Jaune Achesa.

In his opening remarks, the Chairman thanked members for their zeal to serve the people of Shinyalu whenever they are called upon.



MIN2: 08/09/2021 - MATTERS ARISING FROM THE PREVIOUS MINUTES

- The Fund Account Manager informed the Committee that works had resumed in Projects that had been flagged in the previous meeting.
- It was noted that Bursary payments had been effected as approved in the previous meeting,

MIN3: 08/09/2021 - WARD REPORT

The Chairman informed the members that he is mandated by the NGCDF Act to hold Ward Forums together with the Committee biannually in order to collect views from the public on Projects they prefer before they are prioritized by the Committee and sent to the Board for approval.

He thanked members for their cooperation during the recently concluded Public Participation meetings, noting that the activity was successful due to the effective mobilization of the various stakeholders that included the members of the public, County Government representatives, Security Agencies and different Heads of departments within the Sub-County.

The Chairman tabled the Ward Forums Report before the Committee for adoption, noting that it is a product of wide consultation between the Committee and the relevant stakeholders.

Members unanimously adopted the report, which they agreed shall form a basis for Budget preparation for the Financial Year 2021 / 2022.

MIN4: 08/09/2021 ~ FY 2021 / 2022 BUDGET PROPOSAL

The Fund Account Manager tabled the before the Committee Circular No. No. NG-CDF/CEO/BOARD CIRCULARS Vol II (30), dated 26th August, 2021, highlighting some of the contents of the circular which are in line with provisions of the NGCDF Act on preparation of the Budget.

She reminded them of the following:

- The total allocation is Kshs 137,088,879.00
- Observation of statutory ceilings, including emergency allocation of Kshs 7,192,206.00
- Eligible Projects should be community based, falling under the National Government functions as per the Constitution.
- Priority shall be given to ongoing Projects.

INTRODUCTION 1.0

The NG-Constituency Development Act 2015 stipulates in part 5 section 27 subsection 1 and 2 that the chairperson of the NG-CDFC shall, within the first year of the commencement of a new Parliament and at least once every two years thereafter, convene open forum public meetings in every ward in the constituency to deliberate on development matters in the ward and in the constituency.

The NG-CDFC shall then deliberate on project proposals from all the wards in the constituency and any other projects which the Constituency Committee considers beneficial to the constituency, including joint projects with other constituencies, consider the national development plans and policies and the constituency strategic development plan, and identify a list of priority projects, both immediate and long term, out of which the list of projects to be submitted in accordance with the Act shall be drawn from.

Citizen participation in project planning, management and implementation planning requires the involvement of concerned stakeholders. This includes identifying public concerns and values and developing a broad consensus on planned initiatives. It is also about utilizing the vast amount of information and knowledge that stakeholders hold to find workable, efficient and sustainable solutions

Public participation encompasses a range of procedures and methods designed to consult, involve, and inform the public to allow those that would be potentially affected by a decision or policy to have input into the process. Community participation motivates the stakeholders to work together, recognize the benefits of their involvement and own the projects in their localities

Stakeholders play a central role in setting up priorities and objectives of development Initiatives in order to ensure relevance and appropriateness. It is important that

all stakeholders are involved in the development of projects and not just direct beneficiaries of an initiative.

ABOUT NG-CDF 1.1

The Constituencies Development Fund (CDF) was established under the Constituencies Development Fund (CDF) Act, 2003, amended in 2007 and repealed by the CDF Act of 2013. In 2015, the CDF Act of 2013 was declared unconstitutional and a new Act was enacted in 2015, Act, Development Constituencies Government National the being

NG-CDF Act, 2015. The National Government Constituencies Development Fund (NG-CDF) is FUND ACCOUNT MANAGER under the Ministry of Devolution and Planning.

The Constituency Development Fund (CDF) was introduced in Kenya in 2003 with the passage of the CDF Act 2003 by the 9th Parliament of Kenya which was repealed in 2013 by the CDF Act 2013. The CDF Act provides that the government set aside at least 2.5% of its ordinary revenue for disbursement under the CDF program.

The fund was designed to support constituency-level, grass-root development projects. It was aimed to achieve equitable distribution of development resources across regions and to control imbalances in regional development brought about by partisan politics. It targeted all constituency-level development projects, particularly those aiming to combat poverty at the grassroots and entrench equitable distribution of development.

The objective of the Fund is to provide mechanisms for supplementing implementation of the National Government development Agenda at the constituency level.

The CDF program has facilitated the putting up of new water systems, health and education facilities in all parts of the country, including remote areas that were usually overlooked during funds allocation in national budgets.
