MINUTE 3/01/07/21/NG- CDFC/KASARANI: MATTERS ARISING FROM PREVIOUS MINUTES.

a. Status of court case

The Officer of the Board confirmed having written to the NG-CDF Board seeking for legal advice on the 2nd and final payment to the lawyer, and the response is being awaited to enable the committee make an informed decision.

b. Bursary Forms Issuance

The bursary form issuance is still as scheduled on 5th and 6th July 2021. In preparation of the same, all the chiefs and assistant chiefs are still having the scheduled stakeholders meeting on 2nd July 2021 at Kasarani DCC office.

MINUTE 4/01/07/21/NG- CDFC/KASARANI: PROJECTS RESUBMISSION

The committee noted that there is an amount of Kshs. 2,000,000 for 2016/2017 which was not approved by the headquarter. The amount had been proposed for completion of 3 no. classrooms at Ruai Secondary School. The project had been allocated Kshs. 3,400,000 in FY 014/015 and an additional of Kshs. 2,000,000 in FY 016/017 for its completion, which was not approved. The outstanding issues are yet to be addressed and the committee resolved to allocate this amount to another school, Njiru Secondary (new) school to avoid pro-longed delay in project resubmission.

An amount of Kshs. 2,742,197.41 for FY 2020/2021 for landscaping of Kasarani Deputy County Commissioners field was also given a conditional approval. After some discussion it was noted that the landscaping cannot be implemented at the moment as the field is being utilized as a construction site by the company implementing Kasarani Ruai sewer. It was therefore resolved to also allocate this amount to construction of three classes at Njiru secondary (new) school.
