1.0 INTRODUCTION

1.1 BACK GROUND INFORMATION ABOUT NG-CDF

The Constituencies Development Fund was created by the Constituencies Development Fund Act, 2003 with the primary objective of addressing poverty at grassroots level by dedicating a minimum of 2.5% of the Government ordinary revenue to grassroots development and the reduction of poverty. The fund is managed by the Constituencies Development Fund Board (CDFB)

In January 2013, the CDF Act 2003 (as amended in 2007) was repealed and replaced with CDF Act 2013 that is aligned to the constitution of Kenya 2010.

The enactment of the CDF Act 2013 was mainly aimed to ensure that the law governing CDF is aligned to the Constitution of Kenya 2010, specifically in compliance with the principles of:

- Transparency and accountability,
- Separation of powers; and
- Participation of the people.
- The new law was also aimed to align the operations of the Fund to the new devolved government structure.

1.1.1 KEY CHANGES IN THE CDF ACT 2013


- Reduction in size of the NG-CDF Board from seventeen to eleven members and introduction of a new officer, the Corporation Secretary as secretary to the Board.
- Obviating the role of nominating Bodies in appointment of CDF Board members.
- Separation of roles of the executive vis-à-vis the Legislature.
- Emphasis on the mandatory role of Project Management Committees
- Submission of Project proposals to the Board by the Chairman of the CDFC.
- Change in size of NG-CDFC resulting in reduction of the maximum number of committee members from sixteen (16) to eleven (11).
- Change in the mode of appointment of NG-CDFC members.
- New role of the Area Member of Parliament as ex-officio member rather than Chairman of CDFC.
- Names of the persons appointed as members of the CDFC to be published in Kenya Gazette.
- New structure at County level, the County Projects Committee.
- Fund Account Manager not DDO as AIE holder.

1.2 BACK GROUND INFORMATION ABOUT EMBAKASI EAST CONSTITUENCY

Embakasi East Constituency is an electoral constituency in Kenya. It is one of the constituencies in Nairobi City County. It covers an approximate area of 64.70 Square Kilometer, with a population of 163,858 people. The constituency has five county assembly wards namely: Upper Savanna, Lower Savanna, Embakasi, Utawala and Mihango ward.

OVERVIEW OF FUNDABLE PROJECTS UNDER NG-CD

The eligible projects fundable by NG-CDF as stipulated in section 24 of the NG-CDF (Amendment) Act, 2016 as those that are in:

Respect of works and services falling within the functions of the National Government under the constitution

Must be community based to ensure that the prospective benefits are available to a widespread cross-section of the inhabitants of a particular area.

The ineligible projects include:

Projects supporting religious bodies or religious activities

Projects supporting political bodies or political activities

Recurrent costs of completed projects

Personal awards

Projects targeting a specific club or group of people to the exclusion of others

Projects addressing devolved functions as outlined in the fourth schedule of the constitution of Kenya

CHALLENGES

Overreliance on NG-CDF funds by the public and the restrictive nature of the NG-CDF Act in terms of the scope of projects to be funded.

WAY FORWARD

The area Member of County Assembly should also hold consultative meeting with all the stakeholders to ward off duplication, double funding or concentration of similar of projects in one locality.

FUND ACCOUNT MANAGER

The FAM addressed the public where he thanked the members of the public for participating in the exercise in a very good way. He appreciated the support of the Patron, Hon Babu Owino, the Area Deputy County commissioner, all the Chiefs and Assistant Chiefs and all the opinion leaders in the Constituency. He promised that they will work as a team and ensure that implementation of projects is done on a timely basis and efficient manner. He also sought the attention of the public on issues relating to:

1. ETHICS AND ANTI CORRUPTION

The FAM sensitized the members of the public on the need to be on the lookout when it comes to utilization of public funds. He informed them that NG-CDF funds is a public fund which is a 2.5% of National Government Revenue and which is taxpayers money given back in the society to alleviate poverty at the grass root level. He therefore urged them to be the watchdog and ensure the proposed projects have been implemented. He added that they can act as whistle blowers whenever they get information and especially on the misuse of funds.

2. PREVENTION OF HIV INFECTIONS

The Constituency Aids Control Committee members sensitized members on behavior change and communication in order to reduce the rate of fatalities as a result of HIV infections. The CACC coordinator informed members the rate at which new HIV infections is increasing and therefore worrying. He urged them to abstain and remain faithful to their partners. And this is not possible, one should use a condom be it a male or female. Behavior change and communication was however key because through this, members of the public will get more informed and make informed decisions.

3. ALCOHOL AND DRUG ABUSE

The Deputy County Commissioner in charge of security and administration reminded the members of the public on the need to eradicate the menace on alcohol and drugs in the area. He attested to them the negative effect it has brought to the economy of the country socially, economically, politically and internationally. It emerged that that there is increased break ups in our families due to irresponsibility among parents, weak citizens cannot contribute economically to the country and politically, the numbers reduce. There are increased cases of partners killing one another after disagreeing on issues leaving children who become orphans and who end up in the gang world hence compromising our security. It is in this regard that the Deputy County Commissioner urged those engaging in alcohol and drugs by way of either business or entertainment to consider withdrawing completely to enable growth in our families and society.

4. YOUTH AND WOMEN EMPOWERMENT

The Sub County Youth Development Officer in collaboration with Sub County Gender and Social Services Officer insisted on the need for the youth and women to be given opportunities a proportion equal to and not less than 30%. They requested the NG-CDF officials to at least preserve 30% of tenders to the youths and women as a way of promoting growth and access to government tenders. They also requested the youths and women to take advantage of the devolved set aside for them.

They encouraged the duo and urged them to visit the Sub County offices for more information. In regard to employment opportunities, all employing entities to ensure gender balance is adhered to by ensuring equal opportunities to all. Youths were advised to ensure that they are not misused in political development of the country. Instead they should in the front line to promote peace and unity among all residents without looking at our backgrounds in terms of tribe, race and religion. They were encouraged to live in harmony and promote patriotism and nationalism amongst members of the public.

3.6 CONCLUSION

The consultative meetings were successfully carried out in the five wards-(EMBAKASI, UPPER SAVANNAH, LOWER SAVANAH, UTAWALA and MIHAGO) where the public thanked the area Member of Parliament, Deputy County Commissioner (Embakasi sub-county) and other opinion leaders for gracing the occasions.

In particular the members of public applauded the area MP for his involvement in prioritizing the NG-CDF projects to be implemented in the financial year 2022/23 as outlined in the NG-CDF Act Section 22

that....."projects under this Act shall be community based in order to ensure that the prospective benefits are available to a widespread cross section of the inhabitants of a particular area".

In conclusion the members of public/citizens came into agreement that only projects related to education and security were eligible for implementation by the NG-CDF as they should focus on the National Government functions as outlined in the fourth schedule of the Constitution of Kenya, in line with the 2022/2023 National Budget statement.

In addition they called for more civic education on the role of CDF vis-a-vis the County Government.






