MTHR/30/09/002/2021 Consideration and approval of F/Y 2020/2021 Proposal

The committee narrowed down the projects that should be given priority in the 2021-2022 financial year as follows:-

- 1. All primary schools should get renovations for classrooms.
- 2. All on-going projects to be fully funded to completion.
- 3. Projects proposed should not be re-allocated
- 4. All primary schools that don't have secondary schools to be considered in the next financial year for funding to establish new secondary schools.

The following projects were narrowed down by the committee as priorities in the financial year 2021-2022

- 1. Bursaries was allocated 32.8% of the total budget.
- 2. TVET construction in Mabatini ward (NGCDF-MATHARE Contribution 10%) which will be funded by the Ministry of Education.
- 3. Security Projects;
 - a) Construction of Huruma Police Station Administration Block
 - b) Renovation of the Deputy County Commissioner Office and Gate House
- 5. Renovation of various classrooms in Mathare Schools.
