Banisa Primary School, during the financial year 2017/2018, was allocated Kshs 561,206 for the proposed purchase, planting and fencing of trees. The project was proposed under the environment sector and was subsequently approved by the NG-CDF Board and has since not been implemented due to water challenges and needs to be reallocated.

After much deliberation, the committee approved the reallocation of Kshs 561,206 to the proposed construction of a 4-Door pit latrine at Banisa Primary School. Banisa Primary has the highest enrolment in the Constituency and is in dire need of toilets and as such the project would go a long way in solving the said challenges.

The Fund Manager informed the committee that he had received the bill of quantities and drawings for the proposed construction of NG-CDFC Office from the public works officer. He reminded the members the project was conditionally approved for lack of bill of quantities and drawings. The members approved the change of activity to proposed construction of NG-CDF Office from foundation to lintel level Kshs 7,500,000 (FAM's office, Board room, Secretary's office, Accounts office, Registry, Clerk of works office, Procurement office, kitchen, Yard, Store, Chairman's office, Verandah, Reception, waiting bay and Water Tank Kshs 7,050,000 and construction of 4 door Pit Latrine to completion (450,000).

After deliberation the members requested the Fund Manager to forward the bill of quantities and drawings to the NG-CDF Board for approval for the project to be approved.

The Fund Manager informed the members that the request for request for resubmission shall, immediately, be sent to the NG-CDF Board for approval and as such the changes would take effect only after approval by the NG-CDF Board.
