2.0 PREAMBLE:

A team of Quality Assurance and standards officers Led by the SCDE Eldas visited the school at around 11:00 Am.

Bula Higli primary school was located between Basir and Aresewajil settlements approximately 97 kms from Eldas Education Office.

3.0 RESOURCE

3.1Physical resource

3.1.2 Classrooms

The school had two (2) permanent classrooms in good condition. There were no desks in all classrooms, windows and doors were opening outside. The classes had no ramps for learners with disability and the school was fenced with thorny bushes.

3.1.3 Toilets /water source and tanks.

There were two (2) pit latrines – One for girls and one for boys.

3.2 Human resources

Mr. Abdi Mohamed Hassan a form 4 leaver is currently a BOM teacher in the school.

3.2.3 Teaching staff.

The school had one PTA teacher undergoing training who was handling class one and also the acting head teacher at time of visit.

3.2.4 Non-Teaching staff.

The school community employed one male watchman at the time of visit

4.0 Curriculum

The school intended to offer competency- Based Curriculum.

4.1 Land size of ownership.

The school had adequate land well demarcated at the time of visit.

5.0 Enrolment

The school Enrolment for boys and girls was as shown below.

5.0 playground and other recreational facilities.

The school had enough space playground well demarcated and marked for various activities at time of visit.

6.0 Recommendation

- 1. The school land should be fenced to ward off encroachment.
- 2. The school should mark the playground and introduce various games to enhance pupils psychomotor skills.
- 3. The school should construct ramps in all classroom doors for ease of movement by the physically challenged leaners.
- 4. MOE to facilitate registration of the school.
- 5. More classroom should be lobbied for by the community.
- 6. Efforts should be made to construct an administration block.

7.0 Conclusions

The team judged the school to have met the basic standards and recommended for its registration.
