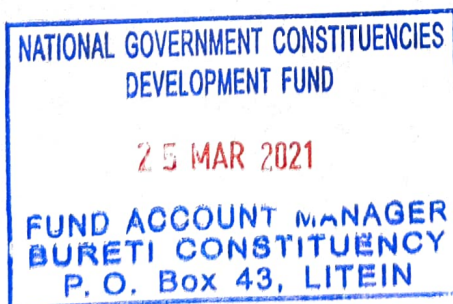

MIN 22/10/2020: CLARIFICATION FOR NGANASET PRIMARY AND CHEMATICH PRIMARY LAND PURCHASE PROJECT

The Fund Account Manager informed members that the NGCDF Board needed more clarification for the proposed land purchase projects for Nganaset Primary School and Chematich Primary School. The Committee clarified that during 2019/2020 F/Y project proposal preparation, the committee intended to expand the Land for Nganaset primary School and Chematich Primary School by 1 Acre respectively. The available funds by then was not enough to Purchase the entire 1 Acre for each school hence the committee allocated funds as follows:-

During 2020/2021 F/Y projects proposal preparation the committee added enough amount of funds to clear the entire 1 Acre land for each school since land valuation for the schools had already been done and forwarded to the NGCDFB for verification. The Schools were funded as follows:-

The meeting ended at 1:00PM with a closing prayer from Rev. Justice Tonui.


