The Secretary went through the previous minutes of 24th April, 2019 which was confirmed as a true record of what was deliberated. The minutes were confirmed by Mr. Patrick Chege and seconded by Ms. Hannah Wambui.

MIN NG-CDFC/NKR. WEST 003/013/085/2018-2019 MATTERS ARISING

- It was reported that the sports tournament kicked off and the tournament is played on weekends.
- The OCS office construction has not started.
- The routine maintenance for Ndarugu bridge to kelelwet Secondary road had started after the ~~procurement~~ was done.

MIN NG-CDFC/NKR. WEST 004/013/086/2018-2019 REALLOCATION & SUBMISSION OF KSHS. 4,677,027.20

The Chairman requested for the status of the funds which was set aside in FY 2017/2018 for the Constituency innovation hub of kshs. 4,677,027.20.

The manager informed the members that the funds of Constituency Innovation hub is in the NG-CDF Nakuru town west bank account at the family Bank, Kenyatta avenue branch account No:018000049795.

The manager confirmed to members that the funds were intact since the day the funds were disbursed to the account.

Through the chair a member sort to know why the funds has taken so long to be reallocated to be used for other development projects.

The members deliberated on the issue and it was noted that Nakuru town west Constituency is a new Constituency which did not have any public facility such as social hall, the DCC offices were also temporary and no office which could be installed with the innovation hub apparatus. It was also noted that the NG-CDF office for Nakuru Town west was operating on a rented office along the kolen road shabaab ward.

It was difficult for the committee to know where the innovation hub could be stationed, however some committee seek to know if the hub could be installed in public schools. Some members were of contrary opinion since Barut primary school which was equipped with computers by a donor were all stolen and computer Lab broken into. It was noted that use of innovation hub in school could result to waste of public resources and also many schools could not allow the youths to access the facilities as its required.

After deliberations members agreed to reallocate the funds which was approved for the Constituency Innovation to other projects.

Members noted that the schools are opening and most of vulnerable students have been sent home for school fees.

It was noted that the bursary was given to form ones who were admitted in public boarding school for first term in full. This amounted to use of more than 60% of the bursary which was meant for the whole constituency.

The member agreed to sort for the approval of some amount from the Constituency Innovation hub to cater for bursaries for secondary school for the needy and vulnerable students.

Members also discussed about the construction of Kaptembwo OCS offices that is police station. It was also noted that the project will include the division headquarters for the Kaptembwo Headquarters .

The Kaptembwo Police Station which includes the OCS wing and the OCPD wing is a mega project and the heart of Nakuru Town West Constituents.

It was noted that during the financial year 2018/2019 the project was allocated kshs Six million (6,000,000.00) which was meant for the construction of OCS offices i.e police station.

It was noted the kaptembwo police station has been upgraded to Kaptembwo police headquarters for Nakuru Town West Subcounty.

The construction included the OCS offices and the OCPD offices which includes offices of the DCIO and traffic commandant.

The manager informed the members that according to public work estimates on the bill of quantity is kshs. 16,989,500.00 (sixteen million nine hundred eighty nine five hundred shillings only).

It was noted that the project is very important for the residents of kaptembwo and Nakuru Town West Constituency. It will serve the whole population of Nakuru Town West Constituency.

After deliberations members agreed to reallocate the funds meant for the Constituency Innovation hub to Kaptembwo Police Headquarters and bursary for Secondary School. The following is the projects the NG-CDFC are requesting for the permission and approval to use the funds for the said purposes.

Members were excited to have the training in Mombasa and were excited for the training.

The members approved kshs 10,000 for miscellaneous expenses during the preparation for the training.

The members approved the payment and requested the chairman to ensure their allowances are paid in time. Members said that some leave their day to day work to ensure they work for the constituents and felts it's their right to be facilitated.

The manager also tabled a budget for the training of NG-CDF as follows: -

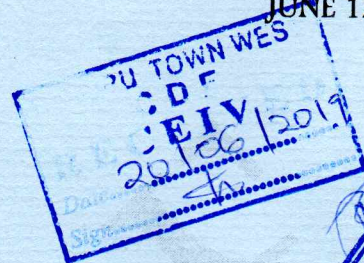
