NG-CDFC/Wajir West/8/03/2023 PRAYERS AND CHAIRMAN'S REMARKS

The chairman thanked the members for their prompt attendance and active participation in all the NG-CDF activities despite the short notice. He also emphasized the need to work very hard so as render services to the people.

NG-CDFC/Wajir West/9/03/2023 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

The secretary read through the minutes of the previous meeting held by the NG-CDFC on 1st March 2023. It was confirmed as true record of what transpired in the meeting by Anab Mohamed and seconded by Mumtaz Abdi.

NG-CDFC/Wajir West/10/03/2023 MATTERS ARISING

The manager informed members of the projects that were conditionally approved and deferred by the Board. These included Hadado TVET where the Board required the NG-CDFC to submit approval letter from the Ministry of Education for establishment of the Institute, purchase of laboratory equipment for Hudhile Mixed

Secondary School where the Board required the NG-CDFC to specify the laboratory equipment to be purchased and their related costs and finally Bursary Scheme that was deferred subject to the NG-CDFC providing a reasonable justification for allocating funds to bursary beyond the required ceiling of 35%. The bursary allocation in normal ceiling would be Kshs. 48,375,261.55, However the Committee allocated Kshs. 55,000,000 which is an increase of Kshs. 6,624,738.45, which the committee resolved to take to Bursary tertiary. This additional allocation comprises of Kshs. 5,000,000 initially allocated to Hadado TVET. The Committee shelved funding of TVET after they consulted the relevant Ministry and were informed that ministry has no allocation to TVETs.

Members discussed the issue of bursary and the following were given as the main reasons for allocating more funds to bursary:

- The provision in the amended NG-CDF Act 2022 in section 48 (A) that provides that constituency committee may, with the approval of the Board, allocate additional funds to cater for education bursary schemes and education days and other teaching and learning related activities.
- The severe drought that has hit the constituency thus many people turned into destitute. The rural areas have completely lost their livelihoods to the ravaging drought and now depend solely on relief food rations from government and donors. It is against this background that parents will not be able to pay school fees for their children. This means that bursary allocation has to be increased to accommodate the ever-increasing applicants.
- The high demand for bursary as is shown in the last 3 to 4 financial years. The statistics on bursary as shown below for the last sampled 3 financial years shows that bursary allocation has never been enough to accommodate all the applicants


