MIN1/11/BN/NG-CDFC/MAY/2022 - PREAMBLE

The meeting come to order at 11:20Am and the chairman welcomed members to the meeting and thank each member for coming in time then requested Stellah Marti to open with a word of prayer.

MIN2/11/BN/NG-CDFC/MAY/2022 - READING OF PREVIOUS MINUTES

The secretary read through the previous meeting minutes and thereafter it was proposed by Moses Kachumo and seconded by Rodah Toroitich for adoption.

MIN3/11/BN/NG-CDFC/MAY/2022 - MATTERS ARISING

There were no matters arising.

MIN4/11/BN/NG-CDFC/MAY/2022 – PROJECT RE-ALLOCATION

The manager informed the members that the Moi Kabartonjo Day Secondary school had written a letter requesting the NG-CDFC to change the project activity from one storey building to twin laboratory. The committee made a request following a board meeting deliberating on the same because the initial project might take more time to be completed considering the cost and the time the Project has taken to be started.

Resolution

After lengthy deliberations members agreed that the manager to forward their request to NG-CDF Board for consideration and the NG-CDFC to allocate a balance of **Kshs. 3,500,000** (Three Million Five Hundred Thousand Only) during financial year 2022/23 for the new project to be completed as per the revised bill of quantities.

MIN5/11/BN/NG-CDFC/MAY/2022 – RESUBMISSION REPORT FROM PMC AND COMMUNITY REQUEST TO CHANGE THE PROJECT NAME

The chairman read through the request report made by the PMC and the community of Katiorin Resource Centre. They had requested that the project be converted to Chiefs Office as the area chief has no office.

After the deliberation the NG-CDFC resolved to have the project be changed from Katiorin Community Resource Centre to Katiorin Locational Chief's Office and the Social hall being part of the project be under the chief once completed. The PMC Chair had requested the NG-CDF office to allocate enough funds to complete the project and put into intended use, a sentiment which was echoed by the chair NG-CDF and accepted by the committee. The NG-CDFC also committed themselves to allocate the balance of Kshs. 2,753,109.20 (Two Million Seven Hundred and Fifty-Three Thousand One Hundred and Nine and Twenty Cents) during financial year 2022/23 to complete the project as the amount allocated of Kshs. 500,000 would only be enough for internal plastering considering the size of the building.

MIN 6/11/BN/NG-CDFC/MAY/2022 – NG-CDF OFFICE CONSTRUCTION PROJECT REPORT

The chairman informed members that the contractor had requested for inspection of external civil works of the project to allow payment of the retention fee after completion of the work.

The External Civil Works done are as follows: ~

i. Retaining wall ii.Drainage works iii.Laying of cabros

The contractor had undertaken works costing Kshs. 7,555,150.005therefore the final retention will be Kshs. 755,521.50 and this will be paid after correcting the identified defects within two weeks.

MIN 7/11/BN/NG-CDFC/MAY/2022 - EMERGENCY FUNDS

The chairman tabled a list of emergency request for deliberation by the committee as requested: -

- 1. Poi Primary School Had requested funds for reroofing of nine classrooms which was in deplorable state and pose great risk to the users. The school had requested Kshs. 2,543,706 inclusive of VAT.
- 2. Kilingot Primary School had requested for funds to construct a four door toilet and urinal. The school had requested Kshs. 900,000 because the construction had to be reinforced because of soil texture.
- 3. Sibilo Primary School had requested for funds to construct a four door toilet and urinal. The school had requested Kshs. 900,000 because the construction had to be reinforced because of soil texture.
- 4. Kagir Primary School had requested for funds to construct a four door toilet and urinal. The school had requested Kshs. 900,000 because the construction had to be reinforced because of soil texture.

Min. 01/18/5/2022: Preliminaries

Min. 2/18/5/2022: Design and Name

The chief informed members that the design of the project was registered as Katiorin Community Resource Centre with the Ministry of Social Services and forwarded to CDF for funding together with the names of officials of Project Management Committee (PMC) as required. Since ministry of social services is devolved NGCDF funds national projects only therefore there was need to change to National Government Line Ministries. Since chief has no office there was need to change the project to Chiefs office which will be under ministry of interior for the CDF to continue funding.

Min. 3/18/5/2022: Construction

Thereafter allocation of Ksh. 1.7 million was given which was used to start the construction. Todate the 65×65 ' (4,225 Sq. ft) the structure has used Ksh. 4.2million (foundation –topography of the land provided some challenges) Walling, roofing, window frames, doors and plastering (in some parts).

Min. 4/18 /5/2022: Reaction from the community

The chief gave chances to the members of the public to react and each member who was given a chance supported the project to be under chief's office where the chief and assistant chiefs will occupy the offices and in-charge of the social hall.

The members requested the NG-CDF to complete the project and equip with furniture.

The community unanimously resolved to transfer the project to the chief of the location to use the office and manage it and to be named Katiorin Chief's Office

The PMC thanked the CDF for funding many projects in the location and bursary for needy students.

The meeting adjourned at 4.30 p.m. with a word of prayer by Mr. Joel Rutto. List of names present attached.
