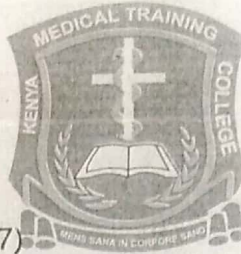

The MP for Kieni had been following it up with the Board and that day the Board visited the site to see the land which had been bought that was 10 acres.

Bacons of the land were shown to the Vice-Chairman of the Board, Directors of the Board, Finance Chair and representative from Treasury, Deputy Director Finance and Administration, KMTC corporate Secretary, Principal & Deputy Principal of Nyeri Campus and Principal Nyahururu campus.

The MP of Kieni had come with the CDF chairman and CDF Fund Manager to participate in the discussions.

Since the land was about 1km from Kiawara Township, where the Health Care facility is located, it was discussed and agreed that they should start with construction of the Classrooms, Abolutions, Administration Block and Hostels for students.


They should also put a big sign post near the Nyahururu-Nyeri road of KMTC Kieni Campus to market the area so that investors can come and start buying plots to come and invest in the area by building shops and rental houses.

The MP informed the KMTC Board that he was also going to construct a hospital there and he had some funds. He was also advised to upgrade the Health Care facility in Kiawara for students to be using it as he starts building another Hospital near the KMTC land. He was asked to buy a bus that will be ferrying students from Kieni campus to various health care facilities which he agreed.

The Member of Parliament was permitted to start developing/constructing KMTC Kieni and was requested to go to the KMTC Headquarters to be given an Architect who will draw a Master Plan for his campus so that everything can be included like the playing fields for students.

The Principal of Nyeri Campus and Deputy were requested to mentor and follow-up that KMTC Kieni campus until it starts functioning which the Principal accepted.
