This request originated from the community, school parents and the B.O.M. The committee deliberated on this and resolved to honour the community request.


## MIN.04/02/03/2022 RE-ALLOCATION

The Assistant chief lower Kiandani reported that the initial ancestral land identified for the construction of the office has got a pending succession case which might take some time to be concluded. The area NG-CDFC representative confirmed that the community has been looking for an alternative land but to no avail. The committee resolved to re-allocate the funds Ksh 1,000,000 to St Patrick's Metuma Secondary School water projects for equipping, distribution and water storage and allocate funds for the assistant chief's office in the next financial year once the land is identified.
