The FAM informed the members that the Sub-County Director of Education advised them to concentrate on the Primary Schools due to high demand of the primary school. There was need to complete the Primary School before embarking on the secondary project.

Members deliberated and unanimously agreed to change the Proposal for the FY 2021/22 from Mjambere Secondary to **Barani Primary School** Construction of six classrooms storey building (Kshs.13,000,000) with five door flushable toilets and three door flushable toilets for Persons With Disabilities to completion(Kshs.1,000,000).
