[Amount in figures], Kenya seven Million one hundred and sixteen Thousand, two hundred and sixty shilling only (Amount in words)the contract is however require to carry out works equivalent to available funds amounting to Ksh. 4,750,000.00 (Amount in figures) Kenya Shillings four million seven hundred and fifty thousand (Amount in words) as directed by the project manager and with the rate in the submitted tender documents.
