- The Government of Kenya (GOK) has received a loan from the International Fund for Agricultural Development (IFAD) towards the cost to scale up the good results of the existing Smallholder Dairy Commercialization Programme (SDCP). It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for supply and delivery of two trucks fitted with cryogenic tanks (2500–3000 litres) to transport liquid nitrogen in Programme Countles.
- The Ministry of Agriculture, Livestock, Fisheries and Irrigation, State Department for Livestock, Smallholder Dairy Commercialization Programme (SDCP) now invites sealed bids from eligible bidders for supply and delivery of two light trucks, 4X2 fitted with 2500–3000 Litres liquid nitrogen Tankers.
