i. Baragothey Police Station

Noted:

- a. there is a request from the Sub-County Police Commandant (SCPC), Hadado Sub-County for the Construction of a Police Station at Baragothey town. The explanation in the letter is that the town is a border town between the counties of Wajir and Isiolo has experienced clan skirmishes pitting the local Degodia clans in Baragothey, Wajir county and their Borana neighbours from Merti, Isiolo county over natural resources, that is, pasture and water for their livestock.
- b. That Baragothey town is now deserted and the local primary school closed.
- c. In a meeting with the executive committee members of the NG-CDFC, the the Sub-County Police Commandant (SCPC) explained that his officers are already in Baragothey and have temporarily converted Gothey primary school to a police camp. This is inconvenient to both the school community and the Police officers.
- d. That the Wajir West NG-CDF to urgently construct a police station at Baragothey town to save lives and livelihoods.

Agreed: that the Construction of administration block at Gothey primary school and part of the construction of 8-roomed staff house with kitchen to completion at Lolkuta North Police station be reallocated to the construction of four roomed staff houses at Baragothey police station.
