PROPOSED CONSTRUCTION OF NEW TECHNICAL VOCATIONAL COLLEGES (TVCs) IN VARIOUS CONSTITUENCIES IN KENYA

The National Assembly has factored Kshs.155mMillion in the Supplementary Budget No.1 of FY 2020/21 of the State Department for Vocational and Technical Training (SDVTT) towards the construction of new Technical Vocational Colleges (TVCs) in Kitui Rural, Kitui Central, Suba South and Kilome constituencies. The construction of a new TVC is a co-financed initiative between the SDVTT and the NG-CDF of the constituency where the new TVC is located.

In addition, SDVTT has created guidelines (see attached) for the establishment of a new TVC.

In view of the foregoing, we seek your indulgence in facilitating the NG-CDF of the above mentioned constituencies to avail the requirements, as enumerated in the guidelines at the earliest possible to ensure that we start the construction of the new TVC within the FY 2020/21. It is especially imperative for your Board to facilitate prompt release of the NG-CDF co-financing contribution of Kshs.10,000,000/- from each of the beneficiary constituency to mentoring institutions to be appointed by PS-SDVTT.

The purpose of this letter, therefore is to inform you of the expected assistance from the NG-CDF Board in the establishment of the new TVCs and to request for your expeditious support when required.
