The 2010 constitution Article 63 (5) classified community land alongside public and private land as having equal status and protection. However, legislation to give effect to this article was not enacted until Sept 2016, when the Community Land Act was passed and the trust land Act and

opportunity to collectively use and manage land  
Community owned by forming Community assemblies  
and community land management committees.
