The chairman thanks all Committee members for their hard work and dedication towards improving utilization of public funds.

NG-CDF/Tarbaj /20/08/2021 Re-allocation of Projects

The Fund manager and the chairman brought to the attention of the members a letter from Duntow primary school board of management requesting for reallocation of the funds available for the Construction of chain link fence with concrete post ,barbered wire and guard house to other priority project activities like renovation of four classrooms, purchase of 40 double decker beds and mattresses and supply of 100 desks. They have indicated that most of the pupils a studying under trees since there classes were blown off by air and they urgently need to safe the situation. Due to the Covid pandemic they have also sighted need for provision of beds, mattresses and desks to enhance social distancing and other Ministry of health guidelines.

The Committee also agreed to relocate Tarbaj Deputy county commissioner fencing project to fencing of Johar mixed day and boarding secondary school.

The initial idea was to acquire new land for the construction of Deputy commissioner's office, chief office , toilets, underground water tank and registrars office and fence it off . but it was later decided to build those structures in the existing compound of the Sub county headquarters which was already fenced by other government department. Therefore the committee unanimously agreed to use the fencing fund available for construction of Construction of chain link fence with concrete post, barbered wire and guard house for Johar mixed day and boys boarding secondary school.
