

MIN. NG-CDFC 012/09/03/2022: PRELIMINARIES

The meeting started with a prayer by Patrick Walutila at 10.15am.

The day's Agenda was read out by the chairman which was proposed by Moureen Mafunga and seconded by Nancy Wanyonyi.

The previous minutes were read out by Moureen Mafunga which were proposed by Fred samukoya and seconded by Patrick Walutila.

MIN. NG-CDFC 013/09/03/2022: PREVIOUS MINUTES

SITE MEETING PROJECTS STATUS

- 1. Nabuyole Secondary School Contractor had deserted the project site. During the meeting held on 10th November 2021, it was agreed that he resumes the construction and complete the pending works electrical contuits, correct the black boards, finish plastering of some areas and cables, painting, fascia board, window panes and shuters, branding and fit sign post- within three weeks. The project was to be completed and handed over by 2nd December, 2021. However, the contractor has not resumed works at the project to date. Reccommendation the contractor be terminated from the project in consultation with current project manager and procurement officer as the contract has been breached so as to help get an alternate way of completing the remaining works.
- 2. Lutacho Secondary School The contractor is about to complete the project but no communication was made to the Country Qs.
- 3. **Sambu Central Primary School** The telephone contact and postal address for the contractor to be availed for further communication.
- 4. Sambu PAG Primary School The site meeting over the isues raised to be held tomorrow between the contractor, School PMC, NG-CDFC team and the Project Manager.
- 5. Ndivisi Boys High School The project to be made up of a 96 bed capacity dormitory, ablution block and septic tank at a cost of Kshs. 9,000,000. The amount first allocated is Kshs. 5.7 million leaving a balance of Kshs. 3.3 million. Misemwa Secondary school had been alloacated Kshs. 2 million in the 2021/2022 financial year which is erroneous as they had already been given the same amount in the 2020/2021 financial year budget to complete the ablution block. Hence, the Kshs. 2 million be re allocated to Ndivisi Boys High School towards the completion of the dormitory. Another Kshs. 1.3 million be spent from the emergency Kit for this year as the project was in itself an emergency case of February, 2021.
- **6. Masindu Secondary School** The contractor is back on site and the correction of errors with completion of pending works is ongoing

LAND ISSUES

- **1. Katumi CEB Primary School Purchase of two acres of land -** The project was approved by the board. Payment have been made to the land owner and there already exists a land title deed.
- 2. Khamoto FYM Secondary School the land issue is still pending. Area member to follow up.

- 3. Bakisa Girls Seconday School the land is ongoing a succession process but meanwhile the land owner has released it to the school and construction is ongoing. The land is atotal of 3.50 acres of which an acre has been valued at Kshs. $828,000 \times 3.5 = 2,898,000$. The amount allocated is Kshs. 3 million which was to purchase 3 acres plus documentation. So meanwhile, we shall have the whole parcel of land purchased as we work on the documentation costs addition from the resubmission amount.
- **4. St. John's Savana RC Secondary School -** No clear answer on the land stalemate. The area member to still make a follow up on the same.
- 5. St. Paul's Nzoia RC Secondary School No progress on the mutation works yet.
- 6. Nzoia Police Post the land is still being searched for.

MIN. NG-CDFC 014/09/03/2022: MONITORING AND EVALUATION ACTIVITIES

The M&E Chairman gave a summary report of the M&E activities carried out in November and December, 2021:

- 1. Project Implementation progress reports the FAM spelt out the various monitoring activities to be undertaken by the members on the recent projects. All the 28 project activities had the sites handed over to the contractors between 21st and 25th February, 2022. The contractors have started works on the projects which requires that the respective members keep a continous and timely monitoring where they equally take project photos and report on the development or any issues that may seem out of line to the Head teacher and Fund Account Manager. A member is expected to visit at least twice during the substructure level, once at the walling level, roofing and finally at the finishes level making it an average of 5 times. At the completion stage, the whole team shall visit for the final inspection in preparation for hand over. Every member shall provide a draft report plus photographs before they are paid. There are some cases where the contractors are yet to start the construction. They shall only be given a grace period of up to 15th March, 2022 after which necessary actions shall have to be taken.
- 2. Mikuva FYM Secondary School A complaint was raised by a contract M/S. Skullab who said he had been sub-contracted by M/s. Washmac who was doing the Laboratory for plumbing works. He was paid part of the works but the contractor passed on in 2017 before the balance of Kshs. 183,240 was paid to him. A meeting was held in the school but a partner of the late contractor did not turn up though he did accept over the phone of being aware of the debt. There is no written contract to proof this. The total sum of works done by the contractor was Kshs. 3,137,840.80 of which Kshs. 2,714,337.50 was paid leaving a balance of Kshs. 423,503.30 with the school out of which Kshs. 313,784 is retention money. It was decided that Kshs. 130,544 be paid to the widow of the deceased who has been issued with a grant to administer the estate, Kshs. 183,240 be paid to M/s. Skullab on provision of a written commitment by the other partner and the balance of Kshs. 109,719.30 shall be paid subject to proof of taxes paid by the second partner who had been given personal cheques to a total of Kshs. 1,144,601 without deduction of VAT with holding Tax and 3% income tax.
- 3. Lutacho FYM Primary School The contractor Ms. Fellow had taken the school to the lawyer demanding for Kshs. 418,086 as his last moety after he was informed of there being no variation amount. However, the teacher in the company of the BOM held a meeting with both

1. PMC Procurement Activities

- A) There are four institutions whose tenders are to be put up locally being:
 - i. Construction of 2 classrooms at Friends Secondary School Wabukhonyi
 - ii. Construction of 2 classrooms at Maraka PEFA Primary School.
 - iii. Construction of 2 classrooms & an exhaustible 4 door pit latrine with urinal at Sirende SA Primary School
 - iv. Construction of a 4 roomed office & exhaustible 2 door pit latrine and a urinal at Assistant Chief's Office Wabukhonyi.

- B) Five institutions with project cost estimates of 5 million and above to be advertised on the PPRA website:
 - i. Ndivisi Girls High School Construction of a 112 bed capacity dormitory and 12 door ablution block at Kshs. 9,000,000
 - ii. Ndivisi Boys High School Construction of a twin dormitory of 148 bed capacity at Kshs. 9,000,000.
 - iii. Sipala Boys Secondary School Construction of a 96 bed capacity dormitoty, a 10 door ablution block and a septic tank at Kshs. 9,000,000.
 - iv. Namarambi Secondary School Construction of a twin laboratory plus furnishings at Kshs. 12 million.
 - v. Construction of 8 classrooms at Kshs. 11,200,000 and a 5 roomed administration block with a staff room at Kshs. 5,234,000 in Webuye ACK Primary School.

2. PMC Procurement Complaints

The members were presented with the procurement complaint that had been presented to the NG-CDF Board by Ms. Hillbace Enterprises Ltd of P.O Box 329 - 50205, WEBUYE dated 24th February, 2022. Meanwhile, the Board has written a letter dated 3rd March and recieved on 7th March, 2022 seeking for clarity on the matter. The grounds of the complaint were alleged multipractices in procurement saying:-

- i. The Company was awarded two projects Sinoko PCU and Mahanga Primary Schools.
- ii. The FAM and Public Works Officer single handedly picked contractors by sidelining the Procurement Officer and the Representatives from the schools without following the due process.
- iii. Up to now, we as tenderers have not received the regret letter informing us the reason why we lost.
- iv. The Contractor requested the NG-CDF Board to investigate how the tenders were awarded to clear the doubts.

Response

The Company - M/S. Hillbace Enterprises limited tendered for three projects being construction of two classrooms to completion at Lwile Sambu PAG, Sinoko PCU and Mahanga PEFA Primary Schools. The bids for the three institutions were not successful due to the following reasons:-

Lwile Sambu PAG Primary School

- i. At Technical evaluation the bid scored **34 points** which is below the cut off mark of 60 points as mandatory requirement.
- ii. The tender document was incomplete at grand summary page with no details of the contractor name and address, witnesses and rubber stamp.
- iii. Erroneous entry of figures on summary page in the tender document cancelled from Kshs. 2,475,940 to Kshs. 2,813,740 but not carried forward to grand summary page.

- i. At Technical evaluation the bid scored **34 points** which is below the cut mark of 60 points as mandatory requirement.
- ii. The tender document was incomplete at grand summary page with no details of the contractor name and address, witnesses and rubber stamp.
- iii. Erroneous entry of figures on summary page in the tender document cancelled from Kshs. 2,230,640 to Kshs. 2,565,040 but not carried forward to grand summary page.

Mahanga PEFA Primary School

- i. Technical evaluation the bid scored **34 points** which is below the cut mark of 60 points as mandatory requirement.
- ii. The tender document was incomplete at grand summary page with no details of the contractor name and address, witnesses and rubber stamp.
- iii. Erroneous entry of figures on summary page in the tender document cancelled from Kshs. 2,346,010 to Kshs. 2,541,210 but not carried forward to grand summary page.

The procurement followed the due process with the tender opening committee being appointed by the respective Head teachers - Two officers from the school and the Fund Account Manager appointing the Procurement officer and a member of the NG-CDFC staff. The Tender evaluation committee was made up of one teacher appointed by the Head teacher and the Fund Account Manager appointed the procurement officer, two technical officers, the project coordinator and a member of the NG-CDFC Staff. The regrets and notice of tender awards were written to the respective bidders.

On close scrutiny, there were two certificates of practical completion attached of which one looked questionable.

The members discussed and saw no reason in the first place that the company passed the preliminary evaluation to technical as it had not filled out the tender documents appropriately. They agreed with the tender results that the contractor was not qualified. Meanwhile, the FAM and Chairman are to go to Vihiga county for a due deligency mission on the genuines of the completion certificate.

3. NG-CDFC Procurement Activities

The request for quotations have been put up for the supply of ICT Equipment and provision of net working services as well as for the provision of motor vehicle services for the NG-CDFC GK vehicle.
