The chairman reported to the members about the partnership program of the Cuban Doctors and Gatundu KMTC which was to be effected in September 2019 with the intake of students to occupy the Mutunguru Institution, however it seems it may take longer period than anticipated and the more Funds are being allocated there seem to be not in use very soon. Members discussed the issue and deliberated to have the

Resource centre funds allocated for construction Ksh. 5,000,000 reallocated to Gatundu KMTC since the population have tremendously grown with the September intake, making the available classrooms overcrowded. NGCDFC member approved the funds to be reallocated for construction of three new classrooms with which shall later be constructed to a storey building.

Through the chairman, members discussed A in A raised during the financial year 2018/19 and 2019/20 through the sale of tender **Ksh. 128,000** and Motor Vehicle **Kshs. 820,000.00** respectively. Members approved to have funds utilized on the below projects:

- (i) **Gatundu Technical Training Institute-** Construction of 5 block toilets – Ksh. 298,000.00
- (ii) **Wamwangi Secondary School-** Construction of 5 Door toilets and urinal – Ksh. 650,000.00

- (i) Members approved the withdrawal of Kshs. 80,000/= to pay for sitting allowances for the current meeting and 23<sup>rd</sup> October 2019 Meeting for finalizing of the Proposal.
