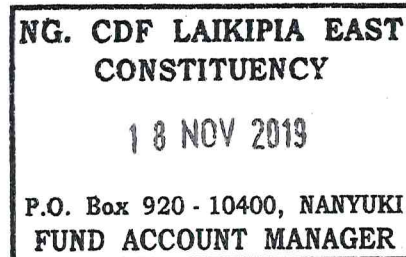

The fund account manager insisted to the committee to fast track in the formation of the project management committee to cater for sports in the constituency.

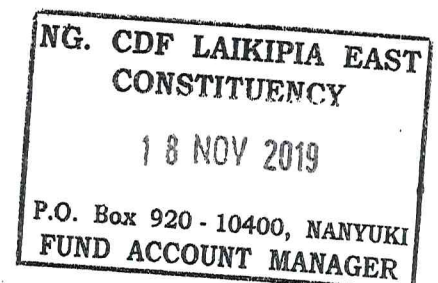
The chairman assured the members that the process is ongoing and almost complete.
