1.0 INTRODUCTION

The NG-Constituency Development Act 2015 stipulates in part 5 section 27 subsection 1 and 2 that the chairperson of the NG-CDFC shall, within the first year of the commencement of a new Parliament and at least once every two years thereafter, convene open forum public participation meetings in every ward in the constituency to deliberate on development matters in the ward and in the constituency.

The NG-CDFC shall then deliberate on project proposals from all the wards in the constituency and any other projects which the Constituency Committee considers beneficial to the constituency, including joint projects with other constituencies, consider the national development plans and policies and the constituency strategic development plan, and identify a list of priority projects, both immediate and long term, out of which the list of projects to be submitted in accordance with the Act shall be drawn from.

Public participation in project planning, management and implementation planning requires the involvement of concerned stakeholders. This includes identifying public concerns and values and developing a broad consensus on planned initiatives. It is also about utilizing the vast amount of information and knowledge that stakeholders hold to find workable, efficient and sustainable solutions to the prevailing constituency needs.

Public participation encompasses a range of procedures and methods designed to consult, involve, and inform the public to allow those that would be potentially affected by a decision or policy to have input into the process. Community participation motivates the stakeholders to work in unity, recognize the benefits of their involvement and own the projects in their areas.

Stakeholders' involvement is imperative since they play a central role in setting up priorities and objectives of development initiatives in order to ensure relevance and appropriateness. It is important that all stakeholders are involved in the identification of projects and not just direct beneficiaries of an endeavor.

1.1 ABOUT NG-CDF

The constituencies Development Fund was created by the Constituencies Development Fund Act, 2003 with the primary objective of addressing poverty at grassroots level by dedicating a minimum of 2.5% of the Government ordinary revenue to grassroots

development and the reduction of poverty. The fund is managed by the Constituencies Development Fund Board (CDFB).

In January 2013, the CDF Act 2003(as amended in 2007) was repealed and replaced with CDF Act 2013 that is aligned to constitution of Kenya 2010. The enactment of the CDF Act 2013 was mainly aimed to ensure that the law governing CDF is aligned to the Constitution of Kenya 2010, specifically in compliance with the principles of;

- Transparency and accountability
- Separation of power and
- Participation of the people
- The new law was also aimed at aligning the operations of the Fund to the new devolved government structure.

1.2 ABOUT WESTLANDS NG-CDF

Westlands is a neighborhood in the city of Nairobi, the capital and largest city in Kenya. Westlands was a residential neighborhood of Nairobi during the colonial period which ended in 1963. During the 1990s and early 2000s, as land and office space became scarce and exorbitantly priced in the central business district, more businesses have relocated to Westlands and Upper Hill, where land and office space are more readily available and less expensive. Westlands was initially considered part of the Parklands area and straddled what is now Waiyaki Way, originally the Kenya Uganda Railway. The area has been nicknamed Westie by the youth of Nairobi.

Westlands Constituency is an electoral constituency in Kenya. It is one of the seventeen constituencies of Nairobi Province. It consists of western and northwestern areas of Nairobi.

Westlands constituency has common boundaries with Westlands Division of Nairobi. The entire constituency is located within the Nairobi City Council area. The constituency has an area of 72.4 km2. It was known as Nairobi Northeast Constituency at the 1963 elections, then as Parklands Constituency and since 1988 elections it has been known as Westlands Constituency.

Westlands constituency contains some of the highest income areas in Nairobi, as well as slum areas like Kangemi.

The Kenyan Constituency Development Fund (CDF) was introduced in 2003 during the Kibaki presidency with the aim of devolving some funds to the grassroots so that people would have a say on development.

The fund is designed to support constituency-level, grass-root development projects. It is aimed at achieving equitable distribution of development resources across regions and to control imbalances in regional development brought about by partisan politics. It targeted all constituency-level development projects, particularly those aiming to combat poverty at the grassroots.



4.3.3 COMMENTS BY THE FIELD OPERATIONS OFFICER



4.3.5 COMMENTS BY THE WESTLANDS NG-CDFC CHAIRMAN


He told the meeting the devolved functions in Westlands and pointed out the importance of taking into consideration all major stakeholders' opinions during the projects' planning stage.



The principal gave her own projects needs as well as presented other secondary schools projects priorities.




