## IMPROVEMENT OF FEEDER ROADS TO SCHOOLS

Please refer to your unreferenced letter dated 14<sup>th</sup> December 2021 on the above subject matter and further to your notes seeking clarification.

We wish to reconfirm and advise on the issues raised on the letter as follows.

- 1) That Kenya Rural Roads Authority (KeRRA) is a state corporation established under the Road Act of 2007 with responsibility of the Management, Development, Rehabilitation, And Maintenance of National Rural roads and therefore, we here confirm that access roads leading to the schools **originate off** from our classified National Government Roads and that they are not on our current KeRRA's Annual Work Programme for FY2021/2022. The main road sections have already been upgraded to **Bitumen Standards** but due to budgetary constraints the authority was unable to improve these access roads to bitumen standards.
- That we have No objection for improvement to gravel standards of the same roads by the National Government Constituencies Development Fund.
- 3) That we have carried out reconnaissance and done road inventory survey of the affected access roads and based on the knowledge and information of the catchment of the area, the historical cost market rates for the last five years, therefore wish to advise that the unit cost for improvement to gravel standard per kilometer is approximately One Million Five Hundred Thousand Shillings (KShs.1,500,000.00) hence a summary of cost estimates are as follows:

1	Morau Centre – Morau Secondary School-Kesongosho (3.5km)	4,200,000.00	Site Clearance, Earthworks, Grading and Gravelling works.	The access road originates from the National classified network Lelu-Kebeneti Road which is a road under KeRRA's jurisdiction

2	Kasheen Center – Kasheen Secondary School (3km)	3,000,000.00	Site Clearance, Earthworks, Grading and Gravelling works.	The access road originates from the National classified network A Mutaragon – Jambo Kenya road which is a road under KeRRA's jurisdiction
3	Ngirimori Centre – Kunyak Secondary School-Njoro (3km)	3,000,000.00	Site Clearance, Earthworks, Grading and Gravelling works.	It is a road under KeRRA's jurisdiction.
4	Lesirwo Centre – Lesirwo Secondary School (1.2km)	1,800,000.00	Site Clearance, Earthworks, Grading and Gravelling works.	The access road originates from the National classified network, Londiani – Muhoroni road

4) We have prepared and enclosed the Bills of Quantiles as requested on a separate cover for your adoption and processing.

You are therefore advised to take further necessary action.
