MPs Remarks

He thanked members for their hard work. He pointed the delay in release of Funds by the Board. This has resulted to delay in implementation of projects where some of them had stalled.

He informed members that they had raised the issue to the Cabinet Secretary Treasury in the Assembly where there was a commitment to be releasing the funds weekly from treasury to the Board then to the respective constituencies awaiting AIE.

It was noted that additional Kshs12M and Kshs 6.9M had been deposited in the account. AIE for Kshs 8.5M had also been received the previous day.

Minutes of the previous minutes dated 25th February were read. They were confirmed to be true records of previous proceedings by Peterson Njiru and seconded by Samuel Njururi.

MIN 4/25/02/2021 DELIVERY OF SCHOOL BUSES

It was noted that bus issuance ceremony to All Saints Kigari day and Muvandori Day secondary proceeded on successfully. The beneficiaries and the community at large were very happy and thanked the NG-CDF fraternity for the good gesture to the schools.

MIN 4/17/03/2021 PRIORITIZATION OF KSHS 8.5M & KSHS 700,000

Funds Manager reported that she had received two AIEs amounting to Kshs 700,000 and Kshs 8.5 M

Members noted that Kshs 700,000 was for Runganga Secondary which was a balance for land Purchase.

Members agreed to release the funds so that the school can fully purchase the land.

Members noted that due to the delay of funds, there were so many emergency cases especially those of collapsing and filling up of school's pit latrines.

There were also increased cases of students being sent home due to fees arrears.

This prompted members to prioritize the available funds of Kshs 8.5 to Emergency and Bursary.

MIN 5/17/03/2021 EMERGENCY ALLOCATION OF KSH 7,100,000

Members noted that there were so many requests received from institutions for latrines funding which had either collapsed while others had filled up.

1. Some projects had stalled due to lack of funds and the contractors were not on site. These were Kenga Day Secondary, Rugumu Day secondary, Urban Day secondary.

2. Some projects were well completed and were in use. These were All Saints Kigari Day secondary. Itabua Day Secondary, Gituri Day Secondary, St Michael Day secondary School.

3. Some projects had not been labeled and had been completed. These were Gituri Day Secondary, Kithimu Primary, St Theresa Girls Secondary School.
